## TELEPHONE INTERVIEW WITH DYLAN TALLEY

Okay, today's date is Friday, May the 21<sup>st</sup>, 2021. The time now is 11:06 a.m. DIRECTOR FRED MAYS in the GBI OFFICE OF PROFESSIONAL STANDARDS. I am speaking with SPECIAL AGENT DYLAN TALLEY, T-A-L-L-E-Y, D-Y-L-A-N. He is currently attending the GBI BASIC ACADEMY at the GEORGIA PUBLIC SAFETY TRAINING CENTER in Forsyth, Georgia. I contacted him at 478-993-4601.

FM: Okay, AGENT TALLEY, I've got a statement here that you provided up through the Chain of Command to our DEPUTY DIRECTOR FOR INVESTIGATIONS CHRIS HOSEY dated May 17<sup>th</sup>, 2021 in reference to the incident on May 12<sup>th</sup>, 2021. Is there anything you want to change, add, or delete to that statement?

DT: Uh, no, sir, I don't.

FM: Okay. Alright, just briefly tell me what you did on that particular evening after class.

DT: Yes, sir, um, I believe it was a Thursday.

FM: Wednesday.

DT: It was a Wednesday, I'm sorry, a Wednesday, um.

FM: Mm hmm.

DT: I have an uncle and aunt that live in, they live in Bolingbroke, um, in Monroe County, and they invited me to come eat with them. And, so I guess it was about 10 'til 6, around that time, about 5:50 p.m., um, I left the TRAINING CENTER, GPSTC, and, um, met my uncle and aunt at their house, and rode with them to, um, Macon to eat with them at Jim Shaw's. And, um, I guess we were there maybe an hour, hour and a half, um, if that, and I rode back with them, um, to their house, and, um, we talked for a little bit. I got in my truck and drove back to

GPSTC. I believe it was around, I'm not a hundred percent direct on the times.

um, but I believe it was around 8:30-ish when I returned. And, um, at no point did

I consume any alcohol at any time, um. I drank water and had a cup of coffee

with my uncle, um, and came back, and I went in my room and went to bed. I

didn't hear or see anything. I didn't know anything happened until the next

morning.

FM: Okay, when you came back in the parking lot of GEORGIA PUBLIC SAFETY

TRAINING CENTER from eating dinner with your uncle and aunt, did you see

any Agents standing around out there around cars?

No, sir, I didn't, um. I parked kinda away from the vehicle, where our vehicles DT:

normally park. I kinda tend to park closer to the main entrance, um, at least

closer on that side. And it was, I remember it was very cold, and, uh, I was

wearing shorts and a tee shirt, so I kinda hurried back to my room. I didn't see.

the only person I passed, I remember the only person I believe I passed was,

um, CHARLIE JOHNSTON in the fover there, um, where our rooms start, where

the barracks are. That's the only person I remember seeing.

FM: Okay. Alright, AGENT TALLEY, is there anything else you want to say before I

turn the tape recorder off?

DT: Um, no, sir.

FM: Okay, the time now is 11:10am. I'm going to turn the tape recorder off.

On Wednesday, May 12, 2021, SA DYLAN TALLEY left GPSTC at approximately 5:50 PM to meet family for dinner. SA TALLEY ate dinner with Mark and Shelly Hendricks (Uncle/Aunt) of Macon, Georgia. SA TALLEY ate at Jim Shaw's Restaurant (Midtown). SA TALLEY enjoyed blackened trout, battered French fries, and hushpuppies. At no time did SA TALLEY consume any alcohol before, during, or after the dinner. SA TALLEY returned to GPSTC at approximately 8:30 PM and went straight to SA TALLEY'S assigned room (#110). SA TALLEY went to bed shortly after returning to room #110. SA TALLEY was unaware of any specific incident until the following morning in class.
