#### To Whom It May Concern:

On 12/21/93 at approximately 01:00 hrs I was at the New Knights night club on Bemiss road in Valdosta Ga. During casual conversation and playing billiards I met Charles Wilson. Wilson asked if my friend Darrin and I wanted to follow him [Wilson] to his home where there were a few women and alcoholic beverages. Upon arrival at Wilson's home I noticed that no one was home as Wilson had stated earlier. Wilson called his girlfriend and relayed to me that his girlfriend and two other girls were on their way to Wilson's house. Wilson and I went to the convenience store to buy cokes for mixing drinks and a bag of ice. When we arrived back at Wilson's home the girls still had not arrived. At this time I was beginning to get an uneasy feeling. I asked Wilson what was taking so long and he called the girls again and said they were on their way. I was beginning to get even more uneasy as Wilson kept refilling my mixed drink. After approximately 45 minutes more the girls still had not shown up to Wilson's house. Wilson and I were sitting on the couch watching T.V. when Wilson reached over with his right hand and grabbed my left knee and began to rub my leg stating " we can have a party with out the girls". I immediately jumped up from the couch and made a statement in a loud boisterous tone to the effect 'I am not a homosexual what the fuck are you thinking. I then pulled a derringer pistol out of my jacket pocket and told Wilson I am leaving here don't fuck with me. At no time did I point the pistol at or in Wilson's direction. I just wanted him to leave me alone and know that I will defend myself if necessary to prevent a sexual assault from him. I then departed the house and got in my truck and drove away. Approximately 5 minutes after leaving Wilson's house I realized that I had forgot my glasses in Wilson house. I turned around and returned to Wilson's home. I had a 9mm pistol in the waistband of my jeans for self-defense in case Wilson tried to assault me again. I knocked on the door several times yelling I just need my glasses and I will leave. After no response I then turned around and headed

back to my truck. At this point V.P.D. arrived and placed me under arrest. They never asked or wanted my side of the story. They arrested me because of the untruthful statement Mr. Wilson had made to cover himself. Looking back on this event I do realize I made bad judgment calls that night. I do think that it is fair on my behalf to mention that since that night some 14 years ago I have not had any run in's with the law. I am currently serving in the Georgia Army National Guard and have just completed a one year deployment to Iraq in service of my country and the great state of Georgia.
