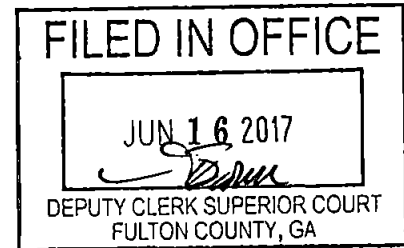

### Recommendation Narrative:

A criminal history check revealed that the defendant has no criminal record on file with Fulton County. The defendant's record indicated that he does not have an Open Case Pending. The defendant is not on Probation or Parole. He has no prior felony convictions, no prior Failure to Appear, and has not been convicted of any violent offenses within the last five years.

The defendant refused to be interviewed; therefore, Pretrial Services was not able to obtain the defendant's address or ties to the community. The defendant's address, employment, drug status, mental/physical health status, probation/parole status, family status could not be assessed because he refused to be interviewed. The defendant appears to be a flight risk because his address and date of birth could not be verified due to his refusal.

The defendant is not recommended for release through Pretrial Services because he refused to be interviewed. If the defendant is released through Pretrial Services, the defendant will be required to submit to a drug court screening. The defendant's RISK LEVEL SCORE is 4.
