Judge Huffman has hereby advised you of the following: public indecency

1. You have the right to remain silent concerning the charges against you and the right to refuse to testify at any stage of the proceedings against you. Your silence does not imply any wrong doing on your part and cannot be used against you. If you give up your right to remain silent, any statement that you make may be used against you.
2. You have the right to be represented by an attorney at all stages of proceedings against you and to have your attorney present anytime you are questioned concerning the charges against you. If you cannot afford to hire an attorney, you may make an application with the court to have an attorney appointed for you.
3. If you have been charged with a violation of city or county local ordinance, you will be permitted to enter a plea of guilty or not guilty. If you plead guilty or do not wish to enter a plea at this time, a hearing will be scheduled.
4. If you are charged with a violation of State authority, you are not required to enter a plea at this time. However, if you wish, you may enter a plea to the charge(s) today, but you may withdraw this plea at anytime before sentencing. Regardless of your plea, a hearing will be scheduled for you in Recorder's Court at which time you will be asked to enter a final plea. Based on your plea, certain actions will be taken. Further options will be explained to you at this hearing. If you wish to waive your hearing in Recorder's Court, you can ask the judge to send your case to the State Court for a bench or jury trial.

no threats and no firearms.


