On Wednesday, September 14, 2016, at approximately 12:15 p.m., Brooks County SHERIFF MIKE DEWEY requested the GBI to investigate an alleged excessive use of force incident involving Brooks County Jail CAPTAIN SCOTT BOUTWELL. The incident occurred on Thursday, September 8, 2016 at approximately 9:15 a.m. GBI SA JASON SEACRIST was assigned the case.

If that footage is not available I would like some footage, a minute of footage of the camera view of where the shower is and the restraint chair.

On Tuesday, September 27, 2016, at approximately 3:00 p.m., GBI SA JASON SEACRIST was located at the Brooks County Sheriff's Office CID Annex, 1004 Holloway Drive, Quitman, Brooks County, Georgia, in regards to the present investigation.

SA SEACRIST met with MARY JANE DRYMAN, the ADMINISTRATIVE ASSISTANT for Brooks County SHERIFF MIKE DEWEY. SA SEACRIST had previously obtained verbal consent from Brooks County Jail ADMINISTRATOR/CAPTAIN SCOTT BOUTWELL to review his personnel file. MARY JANE provided CAPTAIN BOUTWELL'S personnel file that was kept at the Sheriff's Office for review. MARY JANE also noted that there may be another personnel file for CAPTAIN BOUTWELL at the Brooks County Jail.

SA SEACRIST reviewed CAPTAIN BOUTWELL'S personnel file and noted the following:

CAPTAIN BOUTWELL'S original Brooks County Oath of Office was observed and SA SEACRIST made a copy of the original (see attached). SA SEACRIST noted it was administered by SHERIFF DEWEY on April 26, 2010.

In 2009, CAPTAIN BOUTWELL received a P.O.S.T. training waiver for his law enforcement required training hours due to his deployment in Iraq.
