Good day,

Please escalate this to your supervisor.

Per the Georgia Open Records Act, O.C.G.A. § 50-18-70 et seq., I called the City of Cecil at 229-223-3900, and Eishionna Deberry answered the phone. She advised me that I had to fill out a form for open records requests. This is not true. Under the Georgia Open Records Act, O.C.G.A. § 50-18-71(b)(1)(B), a request can be made orally or in writing. I explained to Eishionna that I would not be filling out a form, but she insisted it was the agency's process. When I asked if she would process my request, she hung up on me. Eishionna was very rude and unprofessional.

Please look into my complaint and file it in Eishionna's internal affairs file.

For reference:

- O.C.G.A. § 50-18-71(b)(1)(B): "A request made pursuant to this article may be made to the custodian of a public record orally or in writing."
- O.C.G.A. § 50-18-71(b)(1)(A): "Agencies shall produce for inspection all records responsive to a request within a reasonable amount of time not to exceed three business days of receipt of a request."

I am requesting the following records related to Eishionna Deberry:

- Image on file
- Disciplinary file
- Public complaint file

I am also requesting the following records related to Charity Mobley, who worked for your agency from May 10, 2021, to September 9, 2022, and was then terminated:

- Case files, video, audio, and summary related to her termination
- Image on file
- AXON body cam audit trail for Mobley for the duration of her employment

Finally, I am requesting the payroll listing, including the name, rank, and pay of all employees of the Cecil police department.
