## **NARRATIVE**

ON THE ABOVE DATE AND TIME, I, C. GIDDENS WAS HELPING OFC DAVIS AND SGT TROUTMAN MOVE INMATE ELLER, WALTER FROM P-4 BACK TO POPULATION IN C-DORM. ONCE PAST DOOR 14 INMATE ELLER STOPPED WALKING AND REFUSED TO MOVE ANY FURTHER STATING HE FEARED FOR HIS LIFE BACK THERE. INMATE ELLER WAS INSTRUCTED TO START WALKING AND REFUSED AGAIN I, OFC GIDDENS GRABBED INMATE ELLER ALONG WITH OFC DAVIS AND WE STARTED ESCORTING INMATE ELLER DOWN THE HALL. WHEN WE ARRIVED AT DOOR 16 INMATE ELLER RESISTED HARD SHOVING BACKWARDS AND WE TOOK HIM TO THE GROUND TO BE HANDCUFFED. SGT TROUTMAN HELD INMATE ELLER'S UPPER BODY DOWN TO THE GROUND WHILE OFC DAVIS AND MYSELF HELD THE LOWER HALF OF HIS BODY AND GOT HIS HANDS CUFFED. ONCE HANDCUFFED WE PICKED INMATE ELLER BACK UP TO HIS FEET AND ESCORTED HIM TO A-3 FOR LOCKDOWN AT THIS POINT. ONCE INMATE ELLER WAS PLACED IN A-3 CELL HE STATED HE WANTED HIS PROPERTY BACK AND I, OFC GIDDENS STATED OH NO YOU AINT GETTING NOTHING NOW. INMATE ELLER STARTED HITTING THE CELL DOOR OF A-3 CELL AND STATED IM GOING TO FIND YOU WHEN I GET OUT. I STATED GO FOR IF YOU THINK YOU CAN, SGT TROUTMAN, OFC DAVIS, AND MYSELF EXITED THE DORM AND TURNED AROUND AND WENT BACK WITH CAPT BOUTWELL AFTER MEETING HIM AT DOOR 16. CAPT BOUTWELL TOLD INMATE ELLER HE WOULDN'T RECEIVE HIS PROPERTY WHEN INMATE ELLER ASKED HIM. CAPT BOUTWELL TALKED TO THE OTHER INMATES AND WE ALL EXITED THE DORM. AT 1103 SGT TROUTMAN ADVISED OFC DAVIS TO GO DOWN TO CELL A-3 AND CHECK ON INMATE ELLER DUE TO HIM PUSHING THE BUTTON AND NOT SAYING ANYTHING. AFTER OFC DAVIS AND MYSELF GOT GLOVES WE WENT TO A-3 CELL AND FOUND INMATE ELLER ON THE FLOOR WITH THE JUMPSUIT LEGS WRAPPED AROUND HIS NECK HOLDING ON TO IT CUTTING OFF HIS AIR SUPPLY WITH HIS FACE RED STARTING TO TURN LIGHT BLUE. I, OFC GIDDENS AND OFC DAVIS GOT TO INMATE ELLER AND GOT HIM TO TURN LOOSE OF THE JUMPSUIT AND GOT HIM CUFFED. INMATE ELLER WAS THEN ENROUTE UNDER ESCORT TO P-4 CELL FOR SUICIDE WATCH WHEN WE MET CAPT BOUTWELL AT A-DORM DOOR. INMATE ELLER WAS BEING HELD AT DOOR 16 WHILE WE WAITED FOR MAIN CONTROL TO OPEN IT WHEN INMATE ELLER STARTED COMPLAINING ABOUT HIS CUFFS BEING TO TIGHT AND THAT IT WAS BREAKING HIS ARM AND I, OFC GIDDENS STATED AFTER YOU JUST TRIED KILLING YOURSELF I DON'T CARE ABOUT YOUR ARMS, INMATE ELLER STATED I TRIED TO TELL YALL THAT I FEARED FOR MY LIFE AND YALL DIDNT CARE SO WHY CARE IF I KILL MYSELF. I STATED I DONT CARE ABOUT YOUR ARMS AND YOU GOT THE RIGHT ONES TODAY. INMATE ELLER THEN TRIED TO HEADBUTT ME, THEN CAPT BOUTWELL REACH OVER MY SHOULDER AND SECURED INMATE ELLER'S HEAD AGAINST THE DOOR. DOOR 16 WAS OPENED AND INMATE ELLER WAS ESCORTED TO P-4 AND INSTRUCTED TO GET ON THE BENCH AT THE BACK OF THE CELL AND WAS SECURED AGAINST THE WALL BY OFC DAVIS AND CAPT BOUTWELL WHILE I RETRIVED THE RESTRAINT CHAIR AND SUICIDE SMOCK TO PLACE INMATE ELLER IN TO KEEP HIM FROM HURTING HIMSELF. WHEN I RETURNED WITH THE RESTRAINT CHAIR AND SMOCK INMATE ELLER WAS STRIPPED OF HIS REMAINING CLOTHES AND SECURED INTO THE RESTRAINT CHAIR AND SMOCK PLACED OVER HIM.
