#### **Narrative**

On 09/10/2021, while on routine patrol in the area of Cobb Pkwy and Old Hwy 41 I observed a Silver Infiniti Q40 bearing GA tag BKG7028 traveling north on Cobb Pkwy in the right lane. Prior to going through the intersection of Old Hwy 41, the vehicle failed to maintain its lane. Both of the vehicle's passenger side tires crossed the solid white fog line. The vehicle changed lanes to the left lane, in doing so the vehicle's driver side tires crossed into the gore. The vehicle continued to weave within its lane. I initiated a traffic stop and the vehicle came to a stop in the parking lot of 2699 Cobb Pkwy. I approached the vehicle, informed the driver of the reason for my stop and requested his driver's license. The driver stated that he was an officer too and presented me with his driver's license and a DeKalb County Police Identification Card. The driver was identified as Mr. Jason George. While speaking to Mr. George, I could smell the odor of an alcoholic beverage coming from his person. I also observed his eyes to be bloodshot and glossy. I radioed for backup and Officer Ange responded. Due Mr. George presenting me with a Police Identification Card I radioed for Sgt. Crane to respond to the scene. Once backup arrived on scene, I asked Mr. George to step out of his vehicle and escorted him to the front of my patrol vehicle. Once outside of the vehicle I continued to smell the odor of an alcoholic beverage on Mr. George. I asked Mr. George where he was coming from and he stated that he was coming from a bar. Mr. George stated that he had a couple of beers but he did not drink that much. I asked Mr. George if he would participate in voluntary field sobriety evaluations and he consented.

Mr. George stated that he did not have any head trauma, was not on any medications, nor wore glasses or contacts.

Prior to conducting each evaluation, I explained the instructions and demonstrated each element. Mr. George stated that he understood my instructions.

The following clues were observed during Mr. George's evaluations:

Horizontal Gaze Nystagmus (6 of 6 clues):

Lack of Smooth Pursuit in both eyes. Distinct and sustained nystagmus at maximum deviation Onset of horizontal gaze nystagmus prior to 45 degrees.

Walk and Turn (4 of 8 clues):

Unable to balance
Missed heel to toe
Turned improperly
Stopping during the evaluation

One leg stand (3 of 4 clues):

Swayed Put foot down Used arms to balance

Mr. George provided a voluntary breath sample via the Alco-Sensor breath test, which showed a positive result for alcohol. The results displayed on the Alco-Sensor was 0.129q/210L.

Based on Mr. George's driving, physical behaviors, manifestations, clues

observed during the standard field sobriety evaluations, I determined that Mr. George was under the influence of alcohol and a less safe driver.

Sgt. Crane asked Mr. George if he currently works for the DeKalb County Police Department and Mr. George stated that he did not. He stated he worked for the state as an investigator.

Mr. George was placed under arrest, his hands were handcuffed behind his back, the handcuffs were checked for fit and double locked.

The Georgia Implied Consent notice for drivers over 21 years of age was read to Mr. George from my issued card. I requested the state blood test and Mr. George denied consent.

Mr. George was searched incident to arrest for contraband, none were found.

Mr. George was placed in the rear of my patrol vehicle and his seatbelt fastened. The rear of my patrol vehicle was checked for contraband prior to Mr. George being placed in there, none were found.

Mr. George was transported to the Acworth City Jail without incident.

Mr. George's vehicle was searched for intoxicants and then turned over to Ms. Kysah George per his request. During the search, an unknown liquid was found in a cup, but could not be determined to be an alcoholic beverage.

Mr. George was issued the following citations:

Failure to maintain Lane DUI Less Safe - Alcohol

Due to Mr. George's refusal to the state administered test, a DD1205 was completed and Mr. George's driver's license was confiscated and attached.

Since Mr. George no longer worked for the DeKalb Police Department, the identification card was confiscated.

I returned to the Kennesaw Police department where I processed the Identification card into evidence and secured it in locker 010 with all the necessary paperwork.

My body camera and in car L3 camera systems were activated for this incident.
