Mr. Blume:

I apologize for all delays in this matter. I am assisting the Open Records Unit while the attorney manager is on extended leave for the next several weeks.

As Ms. Green's direct supervisor, I know up front that she has no employee disciplinary records or corrective measures actions. If you want her personnel file, please let me know. The cost of obtaining it and making the necessary redactions for confidential/personal information is estimated at \$5.00, which is the cost of the lowest salaried employee capable of locating, pulling, redacting, and providing the responsive documents, with an expectation of 20 pages in the file. If the file contains more than 20 pages, then the costs will be an additional .025 per page, which is not a copy fee. It is the lowest calculable cost as stated above.

Per the Open Records law, I need to obtain your consent to pay prior to the records being pulled. Please let me know,

50-18-71 (b) (1) (A) Agencies shall produce for inspection all records responsive to a request within a reasonable amount of time not to exceed three business days of receipt of a request

I am asking for this to be escalated to a supervisor higher than Patterson and this complaint to be placed in Nkenge Green's file.
