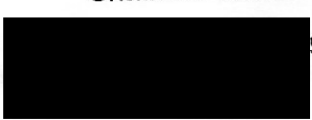

ORDER OF DISPOSITION

Sec. 16-13-49(o)(1); and The State of Georgia having shown that proper service was made upon the known interest holders by personal service pursuant to O.C.G.A. Sec. 16-13-49(o)(2) and notice perfected against all unknown interest holders by publication pursuant to O.C.G.A.
