THAT I WOULD CHECK ON DISPATCH. THIS WAS AROUND 0640HRS
I WALKED INTO DISPATCH AND SAW NO ONE WAS IN THE OFFICE.
I SAW SOME PAPERWORK THAT
HAD PRINTED ON PRINTER AND IT WAS TWO HIT CONFIRMATION
FROM WHITEFIELD 911 ABOUT A STOLEN VEHICLE. WHILE I WAS
IN DISPATCH I OBSERVED A THIRD HIT CONFIRMATION COME

IN DISPATCH AROUND 0650 HRS AND SAW CHARLOTTE AND
DEBRA ON THE PARKING DECK STANDING AROUND
A CAR OUTSIDE. CHARLOTTE FINALLY CAME IN AND I
LEFT DISPATCH AND NOTICED SGT DOT HAYES OF THIS
INCIDENT.
