NARRATIVE

Mr. Richard Russel and Ms. Elizabeth Hillman stated as they were traveling at the listed location they observed Ms. Brittany Thomason attempt to strike Mr. Russel's vehicle with a baseball bat. Mr. Russel also stated he stopped, called the Sheriff's Office, and waited for deputies to arrive. Mr. Russel stated while deputies were en route Ms. Thomason was verbally abusive towards him by saying "I know people who want you dead". Mr. Russel stated there was no damage to his vehicle and he did not know why Ms. Thomason would try to strike his vehicle.

Ms. Brittany Thomason stated Mr. Russel sent several offensive text messages stating "she likes to suck dicks for diet cokes" to her friend, Ms. Megan Hillman's, cell phone. Ms. Thomason also stated due to the offensive text messages she sent a text message to Ms. Megan Hillman's cell phone stating she was going to meet up with Mr. Russel, Ms. Elizabeth Hillman, and Ms. Megan Hillman. Ms. Thomason stated she did not attempt to strike Mr. Russel's vehicle or become verbally abusive towards him but that she wanted to talk to him. Ms. Thomason stated Mr. Russell agreed to meet her, and that she only brought the bat for protection because he had threatened her in the past.

Upon the deputies arrival Ms. Thomason was observed holding a baseball bat. Both parties had conflicting reports and the deputies investigation revealed that there is a history of problems between both Mr. Russel and Ms. Thomason. Also there were no unbiased witnesses to the incident so no further action was taken at this time. Mr. Russel was advised of pre-warrant remedies and given a Victim's Assistance pamphlet.
