NARRATIVE

Mr. Orander called and stated that he has had several problems with Mr. Russell walking around causing a disturbance late at night, and that Mr. Russell has been coming onto his property late at night. Tonight, according to Mr. Orander, Mr. Russell began beating on the community mail box causing a disturbance. Mr. Orander yelled at him to stop at which point Mr. Russell then kicked the mailbox.
