NARRATIVE

Whitney Hillman stated she received a Good Behavior Order against Richard Russell on 071012. Since that time, Mr. Russell called the Sheriff's Office about loud parties at Ms. Hillman's residence on 071512 and 082112. On both occasions, there was no loud party at Ms. Hillman's residence. On 071512, Mr. Russell stated he lived at 107 Coach Lane, a vacant residence. I listened to both phone calls with dispatch and confirmed the caller was Mr. Russell. I recognized Mr. Russell's voice from speaking with him numerous times over the last several years. I spoke with Judge Nelson and he agreed Mr. Russell violated the Good Behavior Order and scheduled a Rule Nisi hearing. I advised Ms. Hillman of available remedies and services. A copy of the phone calls was turned into evidence on Property Receipt # P41567.
