NARRATIVE

I responded to the listed location in reference to a family trouble dispute. Upon arrival I spoke with Mrs. Smitherman (complainant) and her friend, Richard Russell (witness). Mrs. Smitherman stated she and her husband, Grady Smitherman, are separated but still legally married. He currently resides at 221 Stephens Road with a friend, a connecting street with the listed location. Mr. Smitherman was taking care of their one year old juvenile daughter and was asked to bring her back to the listed location at 20:00 hours. Mrs. Smitherman called her husband at 19:48 hours and asked him to bring her back. She said he told her no and for her to come pick their child up so they could talk. Mrs. Smitherman agreed and went to his address and brought along a friend, Richard Russell. She stated he still would not give her their daughter and his reason was because she brought Mr. Russell with her. Mrs. Smitherman stated Mr. Russell is only a friend but her husband feels like he is getting too involved in their relationship. After approximately ten minutes, Mr. Smitherman gave their child back and Mrs. Smitherman returned to her residence.

I spoke, in person, with Mr. Smitherman at 221 Stephens Road. He stated he wanted his wife to pick up their daughter so they could talk about their relationship. He advised he got upset when she brought over Mr. Russell and did not want to give their daughter back if he was going to be there. Mr. Russell use to be a mutual friend until Mr. Smitherman felt like he was trying to move in on his family. Mr. Smitherman eventually gave their daughter back and Mrs. Smitherman returned to her residence.

Mr. Russell stated he and Mrs. Smitherman are only friends and when they separated he took Mrs. Smitherman's side.

Mrs. Smitherman is aware that she and her husband have equal rights to their children and all marital property. She requested this report be filed for documentation purposes only. Mr. and Mrs. Smitherman were advised of available remedies and services.
