**NARRATIVE**

The complainant, Richard Russell, stated he went to check on his Aunt's, Janet Baldwin, house/property while she is out of state. He found the front security gate unsecured with the chain/lock missing. He also discovered that someone removed a 1940s model green Army Willis Jeep. The unrunning Jeep had been parked in a carport built into the game building on the south side from the main house. Tire tracks of an unknown truck used to remove the Jeep were seen in the grass.
