NARRATIVE

Deputies responded to the listed address in reference to a trespass and spoke with Jonathan Otis.

Jonathan Otis stated that a male subject that he recognized from his trail cameras footage came to his front door and began to knock several times. Mr. Otis stated he did not answer since he did not know the subject. Mr. Otis stated the male then walked into the neighbor's yard and walked to the wooded area of the property and began walking towards the back of his property. Mr. Otis stated the male subject had taken his feeder from his property and was walking back towards the front of the property.

I located the male subject coming out from the woods and directed the male to drop the feeder. The male subject identified as Russell Lowe and stated he was armed. I secured the weapons and walked back to the front of the property.

Russell Lowe stated he came to the residence to talk with the owners about their feeder being on his property. Mr. Lowe stated he attempted several times but had no answer. Mr. Lowe stated he then walked into the woods and got the feeder from his property was going to place at the front of the residence.

Deputy Greene went with Jonathan to the back of the property and did not see property marks stated their end of the property.

Jonathan Otis put father Patrick Otis on the phone who stated he bought the property 15 years ago and had a land survey done. Patrick stated there should be metal poles at the end of his property and wishes for Russell not to return to the property. Patrick Otis was advised of remedies.
