#### NARRATIVE

ON THE ABOVE DATE AND APPROXIMATE TIME; I, OFC R.GRIFFIN, ALONG WITH OFC DAVIS, WAS CONDUCTING FEED OFF IN D POD. INMATE #9679 STATEN, TONY WAS THE FIRST IN LINE TO GET HIS SANDWICHES. I HANDED INMATE STATEN HIS DIABETIC SANDWICHES. AND INMATE STATEN STATED THAT HE WASN'T GOING TO EAT TWO PEANUT BUTTER SANDWICHES, AND THAT HE WANTED A MEAT SANDWICH. I EXPLAINED TO INMATE STATEN THAT ALL DIABETICS RECEIVE TWO PEANUT BUTTER SANDWICHES AND NO MEAT SANDWICH. INMATE STATEN GOT AGITATED AND SAID "FUCK THIS SHIT," AND THREW HIS SANDWICHES TOWARDS OFC DAVIS AND I. OFC MOBLEY WAS WALKING INTO THE POD WHEN HE THREW THE SANDWICHES, THE SANDWICHES WENT BETWEEN OFC DAVIS AND I AND HIT OFC MOBLEY IN THE ARM. INMATE STATEN WENT STRAIGHT TO HIS CELL AFTER HE THREW THE SANDWICHES. I FOLLOWED HIM TO HIS CELL AND INSTRUCTED HIM TO GET HIS STUFF TOGETHER. INMATE STATEN SAT ON THE BENCH AND BEGAN CRYING STATING THAT HE COULDN'T EAT TWO PEANUT BUTTER SANDWICHES, I AGAIN EXPLAINED TO HIM THAT ALL DIABETICS RECEIVE THE SAME THING. I, AGAIN, INSTRUCTED INMATE STATEN TO PACK HIS STUFF UP BECAUSE HE WAS GOING TO LOCKDOWN, INMATE STATEN CONTINUED TO REFUSE. I THEN CALLED OFC DAVIS OVER TO THE CELL, OFC DAVIS LOCKED ALL OTHER INMATES IN THE POD DOWN, AND CAME OVER THE CELL. OFC DAVIS, OFC MOBLEY, AND I CONTINUED TO INSTRUCT INMATE STATEN TO GET HIS THINGS TOGETHER. I THEN CALLED MAIN CONTROL VIA RADIO AND ASKED FOR LT GIDDENS TO COME DOWN AND ASSIST US. LT GIDDENS ARRIVED SHORTLY THEREAFTER. LT GIDDENS INSTRUCTED INMATE STATEN TO GET HIS BELONGINGS TOGETHER TO GO TO LOCKDOWN, INMATE STATEN AGAIN REFUSED. LT GIDDENS THEN STATED "YOU GOT TWO OPTIONS, EITHER YOU CAN GET YOUR STUFF AND COME ON , OR WE CAN MAKE YOU." INMATE STATEN STATED "MAKE ME THEN, LET'S GO." INMATE STATEN HAD BUTTONED UP HIS JUMPSUIT AND GOT INTO A FIGHTING STANCE IN THE CORNER OF HIS CELL BETWEEN THE SHOWER AND THE TOILET. LT GIDDENS THEN ADVANCED ON INMATE STATEN, AND GRABBED HIS RIGHT WRIST, OFC DAVIS AND I WERE BEHIND LT GIDDENS AND OFC DAVIS GRABBED HIS LEFT WRIST, AND WERE ATTEMPTING TO GET INMATE STATEN OFF THE WALL. INMATE STATEN IMMEDIATELY BECAME COMBATIVE, TRYING TO PUNCH AND KICK ALL OF US. INMATE STATEN THEN GRABBED LT GIDDENS LEFT SHIRT SLEEVE TRYING TO REGAIN HIS BALANCE. AT THIS POINT, I TOOK THE HANDCUFFS OFF THE BACK OF MY BELT, AND BEGAN ATTEMPTING TO GET INMATE STATEN'S LEFT ARM CUFFED. INMATE STATEN STRUGGLED, BUT I WAS EVENTUALLY ABLE TO GET HIS LEFT ARM CUFFED. OFC MOBLEY THEN CAME FROM BEHIND INMATE STATEN AND BEGAN ATTEMPTING TO HELP US GET INMATE STATEN SECURED IN CUFFS, INMATE STATEN BIT OFC MOBLEY ON HER MIDDLE FINGER ON HER LEFT HAND, AND WOULDN'T LET GO. OFC DAVIS THEN BEGAN KNEE STRIKES ON INMATE STATEN'S SIDE TO GET HIM TO RELEASE OFC MOBLEY'S FINGER. WHILE COMING DOWN WITH ONE OF THE KNEE STRIKES, OFC DAVIS HIT HIS SHIN ON THE TOILET BOWL, CAUSING HIS SHIN TO SPLIT OPEN, INMATE STATEN FINALLY LET GO OF OFC MOBLEY'S FINGER. I THEN WAS ABLE TO GET INMATE STATEN'S RIGHT ARM CUFFED. OFC DAVIS, OFC MOBLEY, AND LT GIDDENS WERE ALL STUCK IN THE CORNER OF THE CELL WITH INMATE STATEN IN FRONT OF THEM. SO I GRABBED THE MIDDLE OF THE CUFFS AND ESCORTED INMATE STATEN TO THE MIDDLE OF THE CELL. OFC DAVIS, OFC MOBLEY, AND LT GIDDENS WERE FREED FROM THE CORNER, AND LT GIDDENS CAME AND GRABBED INMATE STATEN'S LEFT ARM, WHILE I GRABBED HIS RIGHT ARM. WE THEN ESCORTED INMATE STATEN UP TO THE P CELLS, AND PLACED HIM IN THE RESTRAINT CHAIR. NURSE ROB CAME AND CHECKED INMATE STATEN AND CHECKED THE RESTRAINTS, MAKING SURE THEY WEREN'T TOO TIGHT. OFC MOBLEY AND OFC DAVIS WERE SENT TO THE HOSPITAL TO GET THEIR INJURIES CHECKED OUT.

ON THE ABOVE DATE AND TIME, I, C. GIDDENS RESPONDED TO TL GRIFFIN CALLING FOR ME TO MEET HER IN CELL D-2 IN D-DORM. UPON ARRIVAL IN CELL D-2, TL GRIFFIN WAS INSIDE CELL D-2 INSTRUCTING INMATE STATEN TO PACK UP HIS STUFF. INMATE STATEN REFUSED. I, THEN STATED YOU GOT TWO OPTIONS, EITHER GET YOUR STUFF AND COME ON OR WE'LL MAKE YOU BUT EITHER WAY YOUR GOING TO LOCK DOWN FOR THROWING SANDWICHES AT AN OFFICER HITTING HER. INMATE STATEN THEN STATED COME ON MAKE ME. I, THEN ADVANCED INMATE STATEN AND GOT AHOLD OF HIM AT THE SHOWER TOILET AREA AT THE BACK OF THE CELL, OFC DAVIS AND TL GRIFFIN WAS BEHIND ME ADVANCING. ONCE I GRABBED AHOLD ON INMATE STATENS RIGHT WRIST OFC DAVIS GRABBED HIS LEFT AND WE STARTED TRYING TO GET HIM OFF THE WALL WHEN INMATE STATEN GRABBED MY LEFT SHIRT SHELVE WHILE HE WAS BECOMING UNBALANCED. TL GRIFFIN STARTED TRYING TO GET INMATE STATEN'S HANDS CUFFED, WHILE OFC MOBLEY CAME BEHIND INMATE STATEN TRYING TO GET AHOLD WHEN SHE GOT BIT BY INMATE STATEN ON HER MIDDLE FINGER OF HER LEFT HAND CAUSING BROKEN SKIN TO THE AREA AND OFC DAVIS TRIED TO MAKE HIM LET HER FINGER GO BY KNEEING HIM WITH HIS RIGHT KNEE AND CAUGHT HIS SHIN ON THE TOWEL BOWL CAUSING HIS SHIN TO BE SPLIT OPEN. TL GRIFFIN AT THIS POINT GOT INMATE STATEN'S LEFT WRIST CUFFED AND WE BEGAN TRYING TO CUFF HIS RIGHT WRIST WHEN INMATE STATEN DROPPED ON TO THE FLOOR AND I IMMEDIATELY BEGAN APPLYING PRESSURE HOLDING DOWN INMATE STATEN'S HEAD SO HE COULDN'T GET LEVERAGE TO GET BACK UP OFF THE GROUND, TL GRIFFIN AND OFC DAVIS GOT INMATE STATENS RIGHT WRIST CUFFED AND TL GRIFFIN AND MYSELF ESCORTED INMATE STATEN TO P-3 CELL AND PLACED INMATE STATEN INTO THE RESTRAINT CHAIR FOR NURSE ROB TO CHECK HIM OUT. NURSE ROB CHECKED INMATE STATEN AND THE RESTRAINTS. OFC MOBLEY AND OFC DAVIS WERE SENT TO THE HOSPITAL TO GET A MEDICAL SCREENING.

ON THE ABOVE DATE AND TIME WHEN I WALKED INTO DORM B, A SANDWICH CAME FLYING DOWN AND HIT ME. I WAS INFORMED BY SGT. GRIFFIN AND OFC. DAVIS THAT INMATE TONY STATEN HAD THROWN THE SANDWICH BECAUSE HE WAS UPSET ABOUT BEING PUT ON A DIABETIC DIET. INMATE STATEN WENT TO HIS CELL. OFC. DAVIS, SGT. GRIFFIN AND MYSELF WENT TO HIS CELL AND TOLD HIM TO GATHER HIS THINGS BECAUSE HE WAS GOING TO LOCK DOWN. INMATE STATEN REFUSED. SGT. GRIFFIN CALLED FOR LT. GIDDENS TO COME TO THE CELL. UPON LT. GIDDENS ARRIVAL INMATE STATEN WAS GIVEN MANY OPPORTUNITIES TO GET HIS THINGS AND GO TO LOCK DOWN. INMATE STATEN REFUSED ALL OF THE ORDERS AND BUTTONED UP HIS JUMP SUITE THEN GOT IN A FIGHTING STANCE AND SAID "LETS GO", WITH HIS FIST HELD UP. LT. GIDDENS AND OFC. DAVIS WENT TO REMOVE INMATE STATEN FROM HIS CELL, HE GOT VERY COMBATIVE FIGHTING OFC. DAVIS ,SGT. GRIFFIN, LT. GIDDENS AND MYSELF. I REACHED AROUND TO HELP GET HIM OFF OF THE OTHER OFFICERS AND HE BIT MY MIDDLE FINGER ON MY LEFT HAND, DRAWING BLOOD. HE WAS VERY COMBATIVE AND IT WAS A STRUGGLE FOR THE OFFICERS TO GET HIM IN HANDCUFFS. THEY WERE ABLE TO GET HIM HANDCUFFED AND BROUGHT HIM TO LOCK DOWN, I WAS SENT TO THE ER TO GET MY FINGER TREATED.
