ON 05/30/2016 AT APPROXIMATELY 17:15, MORVEN PD BROUGHT IN A BLACK FEMALE BY THE NAME OF THOMAS, VICKY. INMATE THOMAS WAS CHARGED WITH DISORDERLY CONDUCT, AND AN 8 HOUR HOLD WAS PLACED BY MORVEN PD. INMATE THOMAS WAS INTOXICATED AND EXTREMELY AGITATED UPON ARRIVAL AT THE JAIL. I CONDUCTED A FRISK SEARCH, AND HAD INMATE THOMAS HAND ME THE CONTENTS OF HER POCKETS. INMATE THOMAS THEN STARTED ARGUING WITH THE MORVEN PD OFFICER THAT BROUGHT HER IN. I WALKED OVER TO THE INMATE AND TRIED TO GET HER TO CALM DOWN BY TALKING TO HER. INMATE THOMAS GOT MORE AGITATED AND STARTED YELLING THAT I WAS IN HER PERSONAL SPACE. INMATE THOMAS THEN PUT HER HANDS OUT VERY CLOSE TO MY FACE, HER FINGER WAS ALMOST TOUCHING MY EYE. I THEN ADVISED INMATE THOMAS TO BACK UP, AND INMATE THOMAS DROPPED HER ARM AND STEPPED CLOSER TO ME, YELLING IN MY FACE, OFC BROWN THEN STEPPED IN FRONT OF ME TELLING INMATE THOMAS TO BACK UP. INMATE THOMAS THEN BEGAN YELLING AT OFC BROWN, POINTING HER FINGER IN OFC BROWN'S FACE. I THEN GRABBED INMATE THOMAS' LEFT ARM IN AN ATTEMPT TO GET INMATE THOMAS OUT OF OFC BROWN'S FACE. INMATE THOMAS THEN BALLED UP HER FIST AND SWUNG AT OFC BROWN'S FACE. AS SOON AS I SAW THAT SHE WAS SWINGING AT OFC BROWN I GRABBED INMATE THOMAS AROUND HER WAIST AND PUT HER AGAINST THE DOOR TO CELL P-2. AS SOON AS MY RIGHT SHOULDER CONNECTED WITH INMATE THOMAS, A SHARP PAIN WENT DOWN THE RIGHT SIDE OF MY NECK, THROUGH MY RIGHT SHOULDER, AND DOWN MY ARM INTO MY HAND. MY ENTIRE RIGHT ARM THEN WENT NUMB AND MY RIGHT HAND BEGAN TINGLING. THERE WAS A BURNING PAIN GOING DOWN THE RIGHT SIDE OF MY NECK INTO MY RIGHT SHOULDER. OFC D.BROWN, OFC J.DAVIS, THE MORVEN PD OFFICER THAT BROUGHT HER IN, AND I THEN BEGAN STRUGGLING WITH INMATE THOMAS TRYING TO GET HER RESTRAINED. INMATE THOMAS THEN BEGAN KICKING HER LEGS OUT, IN AN ATTEMPT TO GET OUT OF OUR GRASP. I THEN ADVISED ALL OFFICERS "LET'S TAKE HER TO THE CHAIR." WE THEN MOVED INMATE THOMAS TOWARDS THE CHAIR. WE RESTRAINED INMATE THOMAS IN THE CHAIR. INMATE THOMAS HAD BEEN COMBATIVE AND UNCOOPERATIVE THE ENTIRE TIME SHE HAD BEEN AT THE JAIL. SHE HAD REFUSED TO GIVE OUT HER INFORMATION AND HAD REFUSED TO BE DRESSED OUT AND GET A SHOWER (WHICH IS MANDATORY IF AN INMATE IS BROUGHT IN AND NOT BONDING RIGHT OUT). AFTER INMATE THOMAS WAS RESTRAINED IN THE CHAIR SHE WAS PLACED IN THE SHOWER BECAUSE SHE WAS REFUSING TO

DO SO BEFORE THE INCIDENT. INMATE WAS THEN PLACED IN DOOR 9 FOR OBSERVATION, STILL IN THE RESTRAINT CHAIR.

ON THE ABOVE DATE AND TIME OFC BROWN NOTICED INMATE THOMAS, VICKIE BECOMING COMBATIVE SO OFC BROWN IMMEDIATELY GOT THE RESTRAINT CHAIR. UPON ARRIVAL BACK TO INTAKE SGT GRIFFIN AND I WERE GETTING READY TO DRESS INMATE THOMAS OUT AND SHE TOLD SGT GRIFFIN TO BACK UP OUT OF HER PERSONAL SPACE BY EXTENDING HER ARM TOWARDS HER FACE. AFTER DOING THIS SEVERAL TIMES INMATE THOMAS STEPPED UP IN SGT GRIFFIN'S FACE. OFC BROWN ADVISED INMATE THOMAS, VICKIE TO STEP BACK. INMATE THOMAS BECAME EVEN MORE COMBATIVE AND BEGAN TO POINT HER FINGER IN OFC BROWN'S FACE. OFC BROWN USED LIGHT FORCE TO GET INMATE THOMAS BACK OUT OF HER FACE. INMATE THOMAS THEN MADE A FIST TO STRIKE AT OFC BROWN AND WAS RESTRAINED FROM THE SIDE BY SGT GRIFFIN. AT THIS TIME WE WERE ASSISTED BY OFC J DAVIS WITH GAINING CONTROL OF INMATE THOMAS, VICKIE TO PUT HER IN THE RESTRAINT CHAIR.
