NARRATIVE

ON THE ABOVE DATE AND TIME, CAPT BOUTWELL AND MYSELF, LT GIDDENS WAS CONDUCTING VISUAL ROUNDS THROUGH THE DORMS. WHILE IN E-DORM CAPT BOUTWELL INSTRUCTED INMATE'S DAVIS, JAMAAL / SMALL, JOHN / AND STATEN, TONY TO WAKE UP AND GET OUT OF BED. ALL THESE INMATES COMPLIED AND GOT UP FROM BED. UPON WALKING DOWN THE BOTTOM TIER OF E-DORM INMATE STYLES, STEPHEN WAS LAYING ON HIS BED WITH THE SHEET AND BLANKET PULLED OVER HIS HEAD. CAPT BOUTWELL TAPPED INMATE STYLES ON THE FOOT AND INSTRUCTED HIM TO WAKE UP AND GET OUT OF BED LIKE THE REST OF THE INMATES. INMATE STYLES WOKE UP AND STATED "WHAT THE FUCK YOU WANT MAN?" CAPT BOUTWELL STATED "YOUR GOING TO GET UP LIKE EVERYBODY ELSE." INMATE STYLES STATED "WHO THE FUCK ARE YOU?" CAPT BOUTWELL STATED "HOLD UP NOW! YOUR GOING BACK IN ORANGE AND THIS CONVERSATION IS OVER, GET YOUR STUFF TOGETHER." CAPT BOUTWELL PROCEEDED TO EXIT E-DORM WHILE I LT GIDDENS REMAINED BEHIND TO MOVE INMATE STYLES OUT OF E-DORM AND INMATE STYLES YELLED AT CAPT BOUTWELL "YOUR A RACIST." CAPT BOUTWELL REPEATED "THIS CONVERSATION IS OVER." OFFICER PYLE MET WITH ME IN E-DORM TO ASSIST WITH THE MOVE OVER TO A-DORM. UPON ENTERING THE HALLWAY INMATE STYLES DEMANDED TO SPEAK WITH CAPT BOUTWELL AND I STATED "ONCE YOUR IN A-DORM I'LL SPEAK WITH HIM ABOUT COMING DOWN AND TALKING TO YOU." I, LT GIDDENS LEFT OFFICER PYLE WITH INMATE STYLES TO RETRIEVE A ORANGE JUMPSUIT. UPON RETURNING I INSTRUCTED INMATE STYLES TO COME ON WHILE OFFICER PYLE HELD DOOR 16 OPEN TO GO TO A-DORM AND INMATE STYLES STATED "I WANT TO TALK TO CAPTAIN." I AGAIN STATED "ONCE YOUR IN A-DORM, I'LL TALK WITH HIM ABOUT IT." AT THAT TIME CAPT BOUTWELL CAME OUT OF B-DORM AND WAS GOING INTO C-DORM WHEN INMATE STYLES DARTED IN DOOR 16 TRYING TO FOLLOW CAPT BOUTWELL INTO C-DORM. I IMMEDIATELY FOLLOWED INMATE STYLES AND GOT IN FRONT OF HIM HOLDING MY ARMS OUT TO THE SIDES AND WAS PUSHING HIM BACKWARDS, CAPT BOUTWELL WAS EXITING C-DORM TO ASSIST AND INMATE STYLES TRIED TO LUNGE AT CAPT BOUTWELL WHICH APPEARED TO BE AN ATTEMPT TO STRIKE CAPT BOUTWELL WHICH WAS BEHIND ME. INMATE STYLES WAS RUSHED OUTSIDE DOOR 16 AND WAS PUSHED INTO THE CART IN THE HALLWAY. OFFICER PYLE PROCEEDED TO GRAB INMATE STYLES WHILE I HAD HIM PUSHED AGAINST THE CART. OFFICER PYLE THEN PLACED HANDCUFFS ON INMATE STYLES AND WE STARTED EASING BACK FROM FORCE WHEN INMATE STYLES LUNGES AGAIN, THIS TIME APPEARING TO TRY TO SPIT AT CAPT BOUTWELL AND I, LT GIDDENS GRABBED AHOLD OF INMATE STYLES MID BODY TRYING TO KEEP A BARRIER AND OFFICER PYLE GRABBED INMATE STYLES FROM THE BACK AND INMATE STYLES WENT TO HEAVILY RESISTING. CAPT BOUTWELL REACHED OVER MY RIGHT SHOULDER AND GRABBING AHOLD OF INMATE STYLES JUMPSUIT, AT WHICH TIME, SGT PROCTOR ARRIVED AND PROCEEDED TO HELP ON OFFICER PYLES SIDE AND WE ALL WENT TO THE GROUND. INMATE STYLES STARTED TRYING TO ROLL OVER WHILE ON THE FLOOR, CONTINUING TO RESIST. CAPT BOUTWELL STATED "QUIT RESISTING." INMATE STYLES STATED "FUCK YOU." AND CONTINUED TO RESIST. CAPT BOUTWELL SWIFTLY CAME UP ON INMATE STYLES LEFT SIDE APPLYING PRESSURE DOWNWARD AND REPEATED "QUIT RESISTING." INMATE STYLES FINALLY COMPLIED. OFFICER PYLE GRABBED INMATE STYLES RIGHT ARM WHILE I GRABBED HIS LEFT ARM AND PICKED HIM UP. I. LT GIDDENS THEN ESCORTED INMATE STYLES HOLDING HIS LEFT ARM WHILE SGT PROCTOR WALKED BEHIND US CALLING FOR THE DOORS TO BE OPENED. INMATE STYLES WAS PLACED IN A-4 CELL LOCKDOWN. END OF REPORT

On the above date and approximate time while passing out canteen in B Dorm, Lt Giddens notified me via radio that I needed to 10-25 E Dorm. I completed passing the bag of canteen and went to E Dorm. Cpt Boutwell told me before I entered E Dorm that Inmate Styles is to be housed in A Dorm/Lock-Down. I entered E Dorm and Lt Giddens was having Inmate Styles roll his property up. Lt Giddens and I escorted Inmate Styles into the hall beside door 16 when Styles saw the Cpt and asked him why he was moving to lock-down. The Captain told him he was being locked down. At this time Inmate Styles became hostile, cursing and became aggressive. At this time Lt Giddens and I restrained Inmate Styles with arm locks, behind his back. I then placed Inmate Styles in handcuffs. Inmate Styles then proceeded to rush toward the Cpt. In a threatening manner and Cpt Boutwell, Lt Giddens and I restrained Inmate Styles face down on the floor. Inmate Styles then complied and was locked-down in A-4.

On the above date, I Sergeant Titania Proctor entered door 14. As I entered door 14, I observed Inmate Stephen Jerome Styles Inmate #6023 on the floor in the hallway between door 16 and 18, Captain Dwayne Scott Boutwell, Lieutenant Courtney Giddens and Officer James Pyle were restraining him. Captain Boutwell stated to the inmate to stop resisting and Inmate Styles stated that he was not resisting, Captain Boutwell repeated himself with the same statement and so did Inmate Styles. As I made my way down the hall, I maneuvered my way around them and to end of the inmate's feet. Inmate Styles was restrained with handcuffs on the floor. Captain Boutwell advised the Inmate Styles to lay flat; Inmate Styles stated that I am laying flat. I then moved his leg off the top of his other leg allowing him to be completely be flat on his stomach. Lt. Giddens escorted Inmate Styles from the hallway into Dorm A-1 and cell A-4 and the items were removed from the cell. End of Statement.
