Re: Officer Furr's Action

A car was reported stolen from the QT on Haynes Bridge around 0746 hours. The driver had left the keys in it. Officer Furr set up on SR 400 near Mansell Road, and saw a car matching the description given on the lookout. He followed the car onto Holcomb Bridge Road and confirmed it was the stolen vehicle. When Officer Tobias caught up with him they stopped the car at the Publix, 1425 Holcomb Bridge Road. The driver had to be removed at gun point because he refused to follow officers' orders. As they reached the car they saw the driver pouring white powder onto the floor board. The powder field tested positive for cocaine. The driver, a known perpetrator, was arrested and taken to the jail for booking (0701-0187).

Officer Furr's quick thinking resulted in the apprehension of the criminal and the car being returned to the owner. He exemplifies the type of officer Alpharetta has become known for. I commend Officer for his quick response and successful closure of this case.

These officers worked together as a team and put away three dangerous drug dealers in the City of Alpharetta.

During the month of August 2006, the *Crime Suppression Unit* (CSU) received numerous complaints of illegal drug activity occurring at unit #8103 from the residents of the Woodlands condominiums. In response to these complaints, members of the CSU conducted surveillance on this residence.

On August 24, 2006, Det. Kahn received information from an anonymous source that the target of this investigation would be traveling from his condo to an

unknown location to pick up a supply of cocaine to distribute that evening. Based on that information, Sgt. Castro and Detectives Kahn and Covert initiated surveillance on unit # 8103.

During the surveillance, Det. Kahn observed Standley traveling West bound on Webb Bridge Road towards his residence. At that time, Det. Kahn noticed that Standley's vehicle had an invalid dealer drive out tag and initiated a traffic stop on his vehicle in front of unit #8103. At that time, Sergeants Castro and Simpson arrived on scene to assist with the traffic stop.

During the traffic stop, Det. Kahn obtained consent to search Standley's vehicle and located a small amount of marijuana. At that time, Standley was arrested for possession of marijuana.

Upon completion of the traffic stop, Sgt. Castro met with the suspect's roommate, who just arrived on the scene. Upon meeting with the suspect's roommate, Sgt. Castro informed the roommate that someone appeared to be in her residence but refused to answer the door. At that time, the roommate advised Sgt. Castro that she had previously been the victim of a robbery and that she would like the officers to conduct a security sweep of the residence. In addition, the roommate advised that there were at least three firearms in the residence. Sgt. Castro, Sgt. Curry, Ofc. Schulman, and Det. Kahn entered the residence to search for possible intruders. Upon clearing the residence and gaining consent to search for her firearms, the CSU and D-Squad officers discovered a black male and a white male in the living area of the apartment and approximately 1.5 ounces of marijuana in 33 individual baggies. At that time, the CSU and D-Squad officers arrested the two suspects and stopped the search of the residence until a warrant could be obtained.

Upon acquiring and executing the search warrant, Det. Kahn, Det. Covert, FTO Porter, Ofc. Schulman, Ofc. Furr, Sgt. Curry, and Sgt. Castro found a Tec-9 machine pistol, a shotgun, approximately 20 grams of cocaine (also individually wrapped for sale), about 20 more grams of marijuana, two digital scales, and a just turned 16 year old girlfriend of the 21 year old suspect hiding in a closet. Upon interviewing the girl, Sgt. Castro found that the suspect has been having sex with her during the last few weeks (when she was 15 years old), as well as providing her with marijuana. Therefore, the suspect was charged with Statutory Rape, Possession of Cocaine with the intent to distribute, Possession of Marijuana with the intent to distribute, and Possession of a firearm during the commission of a felony.

The CSU only had three officers available during this time, and without the assistance of D-Squad, this investigation would not have been a success. It should be noted that at every turn without complaint, these officers worked together

throughout the night until every warrant, report, witness statement, and evidence form was completed, as well as every piece of evidence processed.

Once again, I would like to personally recognize these officers for their commitment, diligent work, and assistance towards this investigation.



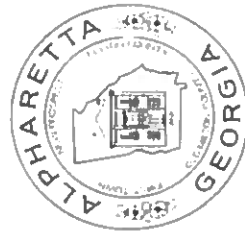


