NARRATIVE/SUPPLEMENT

NARRATIVE #1

On Tuesday April 19, 2022 at approximately 0105 hours Deputy A.S. CARNES with the Gordon County Sheriff's Office Uniform Patrol Division was on routine patrol in the area of Ga-3 and Nicklesville Road when Gordon County E-911 told all deputies that a pursuit was traveling south bound on Interstate 75 into Gordon County.

Deputy CARNES stood by at mile marker 320 and waited for the pursuit to enter Gordon County. Once Deputy CARNES had eyes on the pursuit he joined in at mile marker 320 behind a Tunnel Hill Police Department unit. Deputy CARNES followed behind the white Nissan Altima that Tunnel Hill Police department was pursuing. Deputy CARNES noticed that the Nissan Altima was traveling at a high rate of speed and was driving reckless with no regard for other motorists on the interstate. Deputy CARNES pursued the Nissan Altima south bound on I-75 until a PIT Maneuver was performed on the vehicle in the area of mile marker 311 southbound. Deputy CARNES witnessed the Nissan Altima leave the roadway and strike a tree coming to a rest in the tree line.

Deputy CARNES stopped his patrol unit and began giving verbal commands to the driver of the vehicle. Deputy CARNES saw the driver emerge from the passenger side of the vehicle. Deputy CARNES heard shots being fired and still continued giving verbal commands. Deputies cleared the car and made sure there were no more occupants inside the vehicle. Once the scene was secured deputies stood by until the Georgia Bureau of Investigation arrived to investigate the incident.

NARRATIVE #2

On Tuesday April 19, 2022 at approximately 0105 hours, Deputy W.S. JINRIGHT with the Gordon County Sheriff's Office Uniform Patrol Division was notified by Gordon County 911 that a vehicle pursuit was headed South on Interstate 75. Deputy JINRIGHT told Gordon County 911 that he would be standing by at the 315 South on Ramp Calhoun, Gordon County, Georgia.

Deputy A.S. CARNES took over the pursuit at Exit 320 Southbound. The pursuit continued south on Interstate 75 Deputy JINRIGHT entered the pursuit and continued South. Deputy JINRIGHT became second in the pursuit behind Deputy J.W. STEVENS. Deputy STEVENS set up for a P.I.T. maneuver and the suspect vehicle came over on him and went off the Westside of the interstate.

Deputy JINRIGHT exited his patrol vehicle and went to the front of Deputy CARNES patrol unit. After giving commands the suspect emerged from within the vehicle out of the passenger door. Shots were fired shortly after the suspect emerged. The Georgia Bureau of Investigations was contacted and responded to the scene where they took over the investigation.

On Thursday April 21, 2021 at approximately 0910 hours Deputy JINRIGHT gave a formal statement to GBI Investigator ADAM JONES at the Gordon County Sheriff's Office.

NARRATIVE #3

On Monday, April 19, 2022 shortly after 0100 hours, Deputy G.B. SHIPMAN with the Gordon County Sheriffs Office Uniform Patrol Division responded to the area of Interstate 75 Southbound at mile marker 315 in reference to a vehicle pursuit that was entering Gordon County.

The pursuit passed mile marker 315 and Deputy SHIPMAN entered the pursuit. Deputy STEVENS performed a PIT on the suspect vehicle around mile marker 311. Deputies on scene began giving loud verbal commands to the occupants of the vehicle. The suspect failed to comply with commands and shots were fired at the suspect.

On Thursday, April 21, 2022 at approximately 1000 hours, Deputy SHIPMAN spoke with GBI Agent Eric White and gave a recorded statement. The case is turned over to the GBI at this time.

This incident was audio and video recorded on Deputy SHIPMAN's body worn camera and in car camera.

NARRATIVE/SUPPLEMENT

NARRATIVE #3

On Tuesday April 19th, 2022 at approximately 0057 hours Deputy J.W. STEVENS with the Gordon County Sheriff's Office Uniform Patrol Division received information from Gordon County E-911 that Ringgold Police Department was pursuing a vehicle south on Interstate-75 at mile marker 336. Deputy STEVENS staged at the I-75 southbound on ramp at mile marker 315 awaiting the fleeing suspect vehicle.

At approximately 0100 hours Deputy STEVENS joined in the chase as the second car behind Deputy A.S. CARNES. After approximately 60 seconds Deputy STEVENS took lead in the pursuit. Deputy STEVENS attempted to set up for the Precision Immobilization Technique (PIT) as the suspect vehicle continued to drive 110-115 mph weaving all over the roadway. Near the 311 mile marker Deputy STEVENS had set up on the passenger side of the suspect vehicle. The suspect vehicle was travelling on the left shoulder and began merging back into the left lane. Simultaneously Deputy STEVENS' quarter turned the steering wheel to the left and initiated the PIT maneuver successfully. The suspect vehicle left the roadway off the right shoulder and came to a rest.

Deputies took cover behind patrol vehicles and initiated a felony stop. Deputies gave commands for the driver to exit the vehicle and show his hands. The suspect later emerged from the vehicle and reached to his waist band bringing his hand up and pointing his hand at officers as if he was holding a gun. Deputy STEVENS discharged his firearm in fear for his safety and others around him. The suspect was struck and slumped over. Deputies cleared the vehicle and no other occupants were inside. The scene was then turned over to GBI. This incident was captured by Deputy STEVENS' body worn camera.
