I would like to report a conflict between me and Police Chief Eaton, Lt. Langley and Officer Mobley. There have been several incidents and I feel that it is time to report a formal complaint.

I would like to report the occurrences on record as follows:

On, March 11, 2019 I reported a complaint I received from a defendant that was in the March term of court. Defendant contacted me and stated after court Lt. Langley gave her a business card and told her to call him that he wanted to take her out to lunch. Chief Eaton responses was yeah, he told me he did that and I told him that wasn't a good idea. Later on that, day Chief Eaton and Lt. Langley came to City Hall to confront me about what I reported to Chief Eaton on the complaint I received from the female defendant. Lt. Langley did all the talking and Chief Eaton didn't say anything. I asked why he is discussing this with me he said he wanted to explain his side. I explained I didn't care to hear his side I was just telling Chief Eaton so he could discuss it with him because that does not look good on the department and there was a case a couple months ago that female had filed a law-suite against an agency for the same situation and I would hate to see him jeopardize his job. There have been several incidences where I have spoken with Chief Eaton about something and Chief Eaton would tell Lt. Langley and they would both confront me with what I had spoken with Chief Eaton about. I did not go into details on those incidences because I'm not sure on the dates.

On, March 27, 2019 I receive a message from Officer Mobley, her message stated "It's been told to me that you had a problem with me being in Thomasville the night of that shooting when I ran into you... you and I have already discussed it in detail but apparently it went further than that. and the only thing I have to say about that if you being a deputy's wife, I would expect you would be the first one to want ANY and ALL help to come a running when a deputy screaming for help on the radio." My response to her was I didn't say anything. Reponses keep going back and forth. I will attach conversation. I would like it to also be noted the incident with officer Mobley started after Chief Eaton had a meeting with Police Chair and Mayor on March 26,2019

I feel as if Chief Eaton causes a lot of problems by going back and telling what is discussed with him in private and by saying things that are not to be correct. As a Police chief you manage officers, keep police department strong and communicate with the public. Police work is demanding and stressful, and police chiefs set the tone for the officers in their department, city officials and the public. A police chief should

have excellent leadership skills. With that being said I do not believe Chief Eaton has the leadership skills needed to perform as the City of Boston police chief. As I feel that I am a loyal and hardworking employee, I feel concerned about the situation as it affects me as well as others due to the ordeal created. It has affected me and others and has caused tremendous trouble to existing and has made my work environment unpleasant. I would like to resolve this issue as soon as possible and request you to understand my situation and take appropriate action.
