July 20, 2022 – DEP COBURN notified HCSO he was unable to locate the issued Glock 43 (S/N: AFVK928). DEP COBURN was instructed to file an incident report with the local law enforcement agency. The Glock 43 (S/N: AFVK928) was listed as stolen/lost on GCIC.
