Disciplinary Summary of Ofc. K. Brock

On 06/16/2023 at approximately 1330 Hrs. I Capt. Bradley Thompson was made aware of an issue concerning Ofc. Kenneth Brock cheating on a GPSTC training class. I was also forwarded to recordings Of Ofc. Kenneth Brock speaking to a known individual at the Coweta County 911 Emergency Management Center over the telephone while taking a GPSTC online class test.

I first listened to both recordings and on 06/14/2023 during the evening hours Ofc. Kenneth Brock contacts a female employee known to him at the Coweta County 911 Center and begins reading out questions from an online test he was currently signed in and taking. Both Ofc. Brock and the female employee can be heard discussing the questions and what appears that at one point the female typing looking up information to a question.

After Ofc. Brock reads several questions to the female employee, Ofc. Brock can be heard stating he scored an 83 and again failed the test (Governor's Initiative class Police Legitimacy). Ofc. Brock can be heard while speaking on the phone that he had made several attempts at taking the test and had failed it each time and during the conversation the female employee then can be heard asking if this was a class she could take for Ofc. Brock using his account sign in information to GPSTC.

Ofc. Brock can be heard giving this female 911 Operator his account log in information and she then states to him log out of the site so she can log in and take the test. It should be noted that upon taking any class/test online or in person, each person signs/acknowledges that they will not cheat while on the site or on premises in class.

On 06/16/2023 at 1413 Hrs. After listening to the two recordings sent to me, I then contacted Lt. Kline and Ofc. Kenneth Brock and requested they meet with me at my office. I began the interview with asking Ofc. Brock if he had taken both the use of force and police legitimacy class with him stating yes, he had. I then asked when he took both classes and Ofc. Brock stated he took the police legitimacy class on 06/14/2023 during the evening hours. I asked if he was the one taking the class and his first answer was yes then he stated that after several attempts taking the class his home computer started freezing up so he contacted the known female at the Coweta County 911 center to see if she could help him.

Disciplinary Summary of Ofc. K. Brock

I then asked Ofc. Brock if this female assisted him in any way with answering questions while he was actively taking the test and he stated yes. I then asked Ofc. Brock if this 911 employee used his account information to log in to GPSTC and enter the test as Ofc. Brock and take the test for Ofc. Brock and he stated yes.

I then questioned Ofc. Brock as to the reason for this and he stated due to him having trouble with his computer is the reason he asked for assistance. It should be noted that Ofc. Brock can be heard stating in the phone conversation that he had taken the test multiple times and failed.

I asked Ofc. Brock if he was familiar with the form at the beginning of the online course that he acknowledged/signed stating that he would not cheat while taking the course and he stated he was and that he couldn't give a reason for his actions. At this point I ended the interview and contacted Chief Blankenship with my findings.
