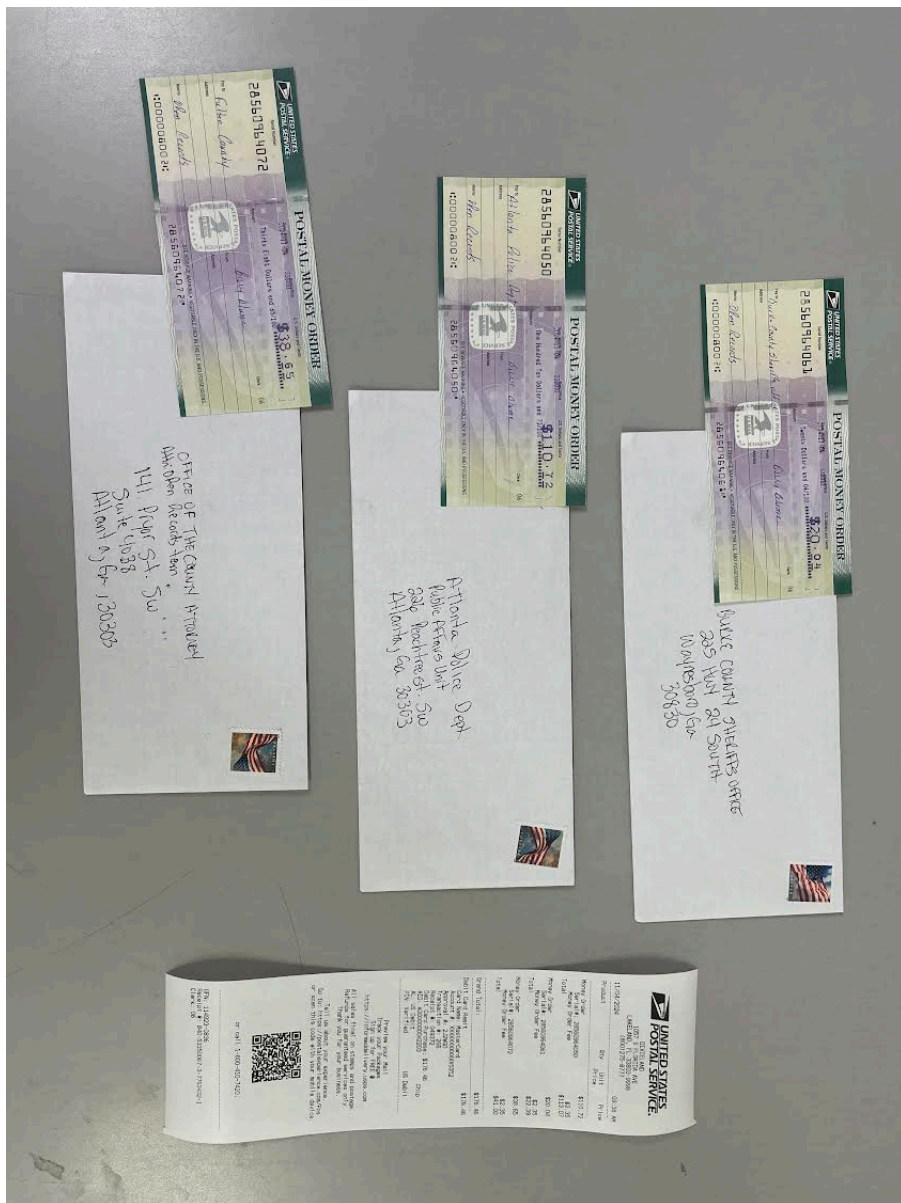

Where is the rest of the body cam?


I requested all body cam from all officers from the incident on 10/24/24 involving Jeremy Huffman. I can prove you without records. You gave me 3 officers. There were 5 on scene when those 3 arrived. There are a lot of blinking lights with no body cam. And only make lawful audio redactions this time. Release the full body cam of all officers on scene from the time the call started until the time the call ended.

Hopefully you can have the rest of the body cam to me by Friday. You are putting yourself at potential risk of litigation in your individual capacity. I also suggest you read article 50-18-74.

I want to make this easy for you,
I am requesting all body cam from all officers for all calls to deal with disturbances related to Jeremy Huffman, the property at 5800 quaker
I am attaching the CAD sheet to help you out. The evening call started at 21:45 however the body cam of the earliest timestamp is 22:54. There seems to be an hour of missing body cam missing, roughly. The CAD sheet states all officers on duty were on scene. I counted 7. Their names are Austin Plueger, Charles Gunn, Laura Turner and of those 3, I received body cam but not from the following officers Sgt Hans, Dylan Mobley, Mikhael Krebs, 1 unidentified officer, sent in previous communication.

I think that is a pretty fair explanation of what I am requesting.
On Monday 11.11.24 I will escalate this to the Attorney General and The Georgia POST council.


I have the 911 calls where Turner said she went out to Huffman's place earlier in the day. So I know it to be a fact there is body cam for that too. She is a LT and should have had that BWC activated.
