On June 15, 2022, at approximately 2:21 PM, SA TENNELL was located at 2100 Kings Chapel Rd, Perry, GA., McEver Probation Detention Center, to conduct an interview with SGT LUCUS MARSHALL. The following is a summary of the interview for full interview refer to the recording attached to this Aciss report.

SGT MARSHALL has worked for the Department of Corrections for four years and started at McEver as a Correctional Officer. Was promoted to Sergeant in 2020 at McEver.

SGT MARSHALL advised that CO HILL had called him "SGT MILK" several times before briefing one day. SGT MARSHALL advised him to call him by his name and CO HILL refused and kept calling him 'SGT MILK'. SGT MARSHALL asked CO HILL what it meant, and CO HILL did not tell him. SGT MARSHALL wrote CO HILL up with an adverse action form.

CO HILL works the night shift.

SGT MARSHALL did not have any issues with CO HILL after that incident.

SGT MARSHALL advised that there was some writing on the wall on the tool shed. "SGT MILK AKA SGT MARSHALL" and "CO HILL" was underneath it.

SGT MARSHALL stated he thinks CO HILL wrote it on the wall. SGT MARSHALL stated on the day he wrote up CO HILL, he said he did not care what happened to him. SGT MARSHALL thinks he went down there and wrote it on the wall to see if he could get away with it.

SGT MARSHALL denied asking someone else to write that on the wall to get CO HILL in to trouble. SGT MARSHALL stated he would take a polygraph.

SGT MARSHALL stated that his brake line was cut at his house but does not think its related to anything occurring at work, but it happened the same weekend.

The interview concluded at 2:30 p.m. For further details, refer to the recording of this interview which was captured using a digital recorder. That recording will be saved electronically in ACISS. The Employee Responsibilities Form signed and dated June 15, 2022, will be placed in a case file and a digital copy will be saved electronically in ACISS. No further action was taken at that time.
