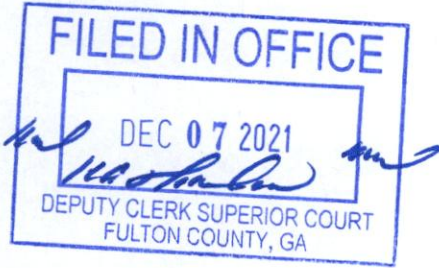

**IN THE SUPERIOR COURT OF SAID COUNTY**

On behalf of the People of the State of Georgia, the undersigned, **Fani T. Willis**, District Attorney, as prosecuting attorney for the County and State aforesaid, does charge and accuse **DALLIS CASH** with the offense of **VIOLATION OF OATH BY PUBLIC OFFICER O.C.G.A. §16-10-1**, for the said accused, in the County of Fulton and State of Georgia, on the 7th day of **December, 2018, having taken and subscribed to an oath of office, as prescribed by law, did in violation of said oath, fail to faithfully discharge his duties when he violated O.C.G.A §16-6-5.1(b)(5) by engaging in sexually explicit conduct with Alexxis Leighton, a person whom the accused knew or reasonably should have known was in the custody of a correctional facility, to wit: the jail in the City of East Point, where the accused was an employee or agent -contrary to the laws of said State, the good order, peace and dignity thereof;**
