§ 50-18-71(b) (1) (A) Agencies shall produce for inspection all records responsive to a request within a reasonable amount of time not to exceed three business days of receipt of a request

I expect this request to be received and read on 1.2.23 and filled no later than 1.5.23

I know there is video, the exemption you are making is (j) No public officer or agency shall be required to prepare new reports, summaries, or compilations not in existence at the time of the request is bogus. *It has been reported there is video.* That exemption is for non existing materials. Body cam from 1985 would be a great example, it simple does not exist.

Sir, you need to comply with the open records act. Your agency, the GBI nor the DA has an open investigation into the Jermaine Jones case. I have verified this with the GBI. If there is an active investigation provide the agency to contact. Otherwise read the following closely.
§ 50-18-72. (a)(8) Records consisting of material obtained in investigations related to the suspension, firing, or investigation of complaints against public officers or employees until ten days after the same has been presented to the agency or an officer for action or the investigation is otherwise concluded or terminated, provided that this paragraph shall not be interpreted to make such investigatory records privileged;
