RE: Access to Public Records and Free Open Government Training

Dear Sheriff Henderson:

We at the Georgia First Amendment Foundation are concerned by complaints about inadequate access to public records held by the Towns County Sheriff's Office. The Foundation has been copied on emails between the Sheriff's Office and Robin Webb of the Towns Observer, who is seeking various public records, including:

- Booking photos
- Officer-narrative portions of incident reports
- Records of government-funded staff training

In addition, Ms. Webb advises she was blocked from commenting on the official Facebook page, facebook.com/TownsCountySheriffsOfficeGA, which is routinely used by the Sheriff's Office to share information with and engage the public. Ms. Webb reported that her access to commenting on the Facebook page was subsequently restored. But the practice of blocking any member of the public from government-administered social media runs contrary to legal requirements and best practices.

The aforementioned complaints indicate the Towns County Sheriff's Office may misunderstand or disregard requirements of the Georgia Open Records Act. Under Georgia law, law enforcement booking photos and incident reports, including officer narratives, are without question public, and they should be provided immediately upon request. State law also requires release, in a timely manner, of many other public documents held by your office.

If documents are withheld for some reason, the Sheriff's Office must comply with O.C.G.A. § 50-18-71(d) and give the code section, subsection and paragraph on which the Sheriff's Office relies for legal authority to exempt it from providing the requested records.

The Foundation is a nonprofit organization that advocates for open government in Georgia. Under our mission, we support Georgians who have questions or concerns about access to public meetings and records. We also provide free training to public officials who would like to better understand and abide by Georgia's Open Records Act and Open Meetings Act.

We have scheduled a free, one-hour open government training session for public officials in Hiawassee at 1 p.m. on Dec. 17, 2021. It will cover open records and meetings laws, as well as government requirements and best practices for social media. We invite you and all members of your staff to attend.
