NARRATIVE

On June 2, 2024 at 1725 hours, Sgt. Megan Inman was working special duty at Walmart (3338 Wrightsboro Rd) when she was notified by complainant (Methvin, Maria) about a shoplifting.

Methvin who is Loss Prevention for Walmart, stated that arrested (Hooks, Dreanna) had been in the store since approximately 1140 hours. Methvin advised that Hooks had made multiple purchases and then concealed the stolen items in gray bags that contained items she purchased. Hooks was stopped at the grocery side exit when she left all points of sale. The items that were stolen and recovered are as follow:

Nova Skin cleaner \$38.84, Neutrogena Acne Stress Cleaner \$9.77, Peach Slice acne treatment \$10.48, Peach Slice acne cleanser \$10.48, Peach Slice acne moisturizer \$12.48, and Neutrogena Acne Stress Control cream \$9.77. The total amount of items stolen from the store was \$91.82. The theft can be observed on multiple cameras throughout the store.

Sgt. Inman asked for Hooks identification in which she first gave the name Felicia Armstrong with DOB: [REDACTED] 1988, then she advised other deputies on scene that her name was Erica Wilson with DOB of [REDACTED]/1987, and Dreanna Hooks with DOB: [REDACTED] 1989. Sgt. Inman was not able to identify Hooks on scene with the information she provided, and she carried the Georgia identification Kalyrics Hobbs with a DOB of [REDACTED]/1995 OLN: [REDACTED]. Sgt. Inman was able to look in the local data base and found the juvenile report where both Hooks sisters were charges with a crime. Sgt. Inman was then able to locate a OLN for Hooks and positively identify her on GCIC/NCIC.

Cpl. Sanderson arrived on scene and transported Hooks to CBWDC for the theft by shoplifting warrant-misdemeanor and giving false name and DOB to officers. Warrants applied for and turned into Records Clerk McNeil C564

BWC available.
