Conduct Unbecoming an Employee
Chapter 3.7 Code of Conduct and Appearance

Dear Sergeant Usry,

I am writing to inform you that as of today, you are terminated from employment with our office for the following violation:

- Conduct Unbecoming an Employee - An employee must at all times, on and off duty, conduct himself in a manner, which does not bring discredit to himself or the BCSO. Conduct unbecoming of an employee will include conduct, which adversely affects the morale, and/or efficiency of the BCSO or which has a tendency to destroy/erode public respect for employees and confidence in the BCSO. To sustain the charge of "Conduct Unbecoming an Employee," it is not necessary that the alleged conduct be criminal in nature nor that it be proven beyond a reasonable doubt. Examples may include, but not be limited to:
 - o Abuse of authority

This action is the result of a matter of significant concern regarding a recent incident involving your conduct as a POST Certified Training Instructor. It has come to my attention that you created a Google Classroom training platform invited certain students to take classes, and then awarded those POST training credits outside of the approved standards of training set by our certification authority. More pointedly, a host of training sessions, of which some are mandatory Governor's Initiatives training (Use of Force, Community Policing, and De-Escalation), did not take place as specified. The training was reported to have occurred on a specific date, at a designated time, for a specific period, and in a specific location. However, our internal investigation has revealed evidence suggesting that the training did not occur in the manner purported, nor was it approved by the GA POST Council. Additionally, you admitted the same during an internal affairs investigation.

The training does not appear to meet POST standards, which require a student to attend 90% of a standalone course. The preliminary investigation shows content material in the courses to be ten minutes or less in several of the courses you created, yet the students received one hour


or more POST credit for each class. The lesson plans you generated grossly undermine the standards set by POST and your actions and decisions have raised serious questions about your honesty and integrity.

Maintaining a high standard of professionalism and ethical behavior is of utmost importance within our organization. Please be aware that the purpose of this investigation is not to single you out or to impose undue punishment, but rather to ensure the integrity of our organization and the trust of the community we serve.

You may appeal the termination in writing to me and a hearing shall be conducted, at which time you are entitled to present facts, information, and relevant evidence as outlined in OCGA Title 50, Chapter 14. All testimony will be under oath, witnesses may be called, and the production of relevant books, records, and documents is permitted.

Please consult with Gloria Golphin Sapp (BCSO) and Renee Mulligan at (County Human Resources) concerning your benefits, vacation, separation notice, or other information. Please talk with your immediate supervisor concerning the return of all property in your possession that belongs to the Burke County Sheriff's Office. Your final paycheck is withheld until such time these obligations have been satisfied.
