I have considered the information contained in complaint report FI 19-009. Furthermore, I have considered your employment history with the Roswell Police Department, and the relative seriousness of the incidents involved. The results of my deliberation are as follows:

I am **sustaining** the findings that you did violate Roswell Police Department Policy and the City of Roswell Human Resources Policies as follows:


- **Roswell Police Department Policy Section 16.1 – Duty To Abide By All Laws and Orders**
  - (A) “Members of this Department will abide by all federal, state and local laws, the directives official communications of the Roswell Police Department, and all City of Roswell Rules and Regulations.”
  - (B) “Written directives apply to members of this Department on-duty, working police related part-time jobs, working special assignments, and various off-duty conduct which is covered by Department rules, regulations, and procedures.”
- **Roswell Police Department Policy Section 16.69 – Violation of Law**
  - “Violation or attempted violation of any Federal, State, County or Municipal law or ordinance is prohibited (whether criminal proceedings are instituted or not).”
- **Roswell Police Department Policy Section 16.82 – Conduct Unbecoming- On/Off Duty Conduct**
  - “Engaging in conduct on or off duty which adversely affects the efficiency of the Department, and has a tendency to destroy public respect for the employee or the Department, or destroys confidence in the operation of the City service is conduct unbecoming and is prohibited.”
- **Human Resources Policy 13.1.2 – “Disregard for and violations of Federal or State Law, City Ordinances, City Policies, Departmental Policies or Regulations...”**
- **Human Resources Policy 13.1.9 – “Any conduct, on or off duty, that reflects unfavorably on the City as an employer”**



It is my order you be Terminated from Employment with the City of Roswell, effective **August 16, 2019**.

**D. Allegation Synopsis**

On July 10, 2019, Lieutenant Larry Arnold (Lt. Arnold) with the Clayton County Police Department Narcotics Unit (CCPD) called Roswell Dispatch and advised the narcotics unit had arrested Communications Officer Malik Parker (Parker) while conducting a search warrant on a house. Lt. Arnold spoke with 911 Deputy Director John Potrzebowski and advised that Parker was charged with O.C.G.A 16-13-30 VGCSA Possession of Marijuana with Intent to Distribute and O.C.G.A 16-13-33 Conspiracy to Violate VGCSA.

**ALLEGATION NO. 1: The Department alleges that on July 10, 2019, Communications Officer Malik Parker, while off duty, was arrested and charged with Possession of Marijuana with Intent to Distribute and Conspiracy to Violate the Official Code of Georgia Annotated.**

**E. Findings of Fact**

The following facts were ascertained during the course of the investigation.

On July 10, 2019, Lt. Arnold with CCPD called Roswell Dispatch and advised that the narcotics unit had arrested Parker, during the execution of a search warrant. The target was a house located at 6369 Havenridge Drive, Riverdale, Clayton County, GA 30274.

The CCPD Investigative Summary stated that officers had the location under surveillance due to information obtained from an informant advising of a "reup" from his supplier (Attachment #1a-1f). At approximately 1435 hours on July 10, 2019, a white Dodge Charger pulled up to the residence and a black male, later identified as Jarontae Dean (Dean), got out of the front passenger seat with a black bag and entered the target location. At that time, a search warrant was executed and yielded approximately 1,307 grams of suspected marijuana, multiple financial transaction cards with various names, magnetic strip cards, an embossing machine, a card reader/writer, electronics, and identification cards. Two hundred dollars of CCPD control buy funds, used during a drug transaction on July 10, 2019, were also located inside the location. During the execution of the search warrant, a free air sniff was conducted on the white Charger driven by

Parker, by a CCPD K9 unit. The K9 had a positive alert to narcotics on the vehicle. A total of four suspects were arrested.

Lt. Arnold spoke with 911 Deputy Director John Potrzebowski and advised that Parker was one of the suspects arrested. Lt. Arnold advised that Parker's employment identification, Roswell 911 jacket and Roswell 911 backpack would be placed into evidence. The Clayton County Sheriff's Office Booking Report states that Parker was arrested for possession of marijuana with intent to distribute and criminal attempt (Attachment #2).

#### **F. Investigation**

On July 10, 2019, a formal investigation was initiated. During the investigation, Parker was interviewed as the subject. Captain Charles Greco (Capt. Greco) served Parker with Administrative Leave and obtained the Investigative Summary from the CCPD. Detective Thomas Robinson (Robinson) assisted Detective Andrew Ross (Ross) in conducting the interview. The interview was digitally recorded by Ross (Attachment #3). Vicky Skinner, Administrative Assistant, transcribed the interview.

#### **Statements**

##### **Communications Officer Malik Parker**

**July 30, 2019**

Parker was given the opportunity to provide an explanation for his arrest. He said on July 10, 2019, he received a phone call from his brother-in-law, Dean<sup>1</sup>. Dean asked for a ride to his friend's house (which later turned out to be the incident location). Parker said that it was not uncommon for him to give Dean or any other family member rides, considering that they do not own vehicles. When Parker met with Dean, it was with the understanding that he would be dropping Dean off, because Parker was on his way to work. According to Parker, Dean brought only a black car seat and his (Dean) six-month-old son. When they arrived at the destination, Dean told Parker he would be right back. Parker stated that he was confused, because originally Dean asked to be dropped off at the location. Parker stated the only reason he did not leave was due to the six month old in the back seat.

Parker said he still did not feel that there was anything suspicious or out of the ordinary going on. According to Parker, when he picked Dean up he did not smell or detect any odors. Parker said that he had been to this particular residence before and was comfortable with giving Dean a ride there. Furthermore, the fact that there was a six month old in the vehicle indicated to him that this was just another errand<sup>2</sup>. Parker said the next thing he knew police were swarming the location. According to Parker, he never exited his vehicle and denied entering the location. He denied any knowledge of what was going on

inside and stated that his charges stemmed from what was located inside the location and there was nothing actually found on his person or inside of his vehicle.

When asked about the location and previous visits, Parker explained that he had been inside in the past. Parker recalled that those visits were always very brief in and that he had never been there without Dean. Dean is the one who introduced Parker and he only knows the individual who lives there by the last name of Stephens. Parker said he had never hung-out with Stephens nor has he ever noticed any drug activity or other illegal activity during past visits. Parker did however state, "These guys are not exemplary of behavior", but again claimed that he did not know exactly what they were into. Parker said he is not sure how a K9 operates, but he believes the "hit" on his vehicle was due to whatever Dean had in his vehicle prior to entering the location. Parker reiterated that he did not actually see Dean with a black bag or any bag for that matter. Parker stated that had he smelled marijuana, he would not have let Dean in his vehicle considering, he could ultimately be held responsible. Furthermore, Parker said he would not have participated in drug activity with the six month old in the vehicle.

Parker explained his relationship with Dean as follows. He has known Dean for approximately seven or eight years. The two spoke on the phone about once a week and he would give Dean a ride about twice a week to various places. During the time that the two have known one another, Parker has only known Dean to work at a warehouse for about one year. Parker has never explicitly had a conversation with Dean about how he makes a living. Parkes stated that he did not want that knowledge. Parker did admit that he was suspicious that Dean was possibly selling drugs or at least involved in illegal activity. Parker denied having any suspicions of illegal activity while running Dean on errands during this particular occasion or in the past. He said that he continued his relationship with Dean, due to the family dynamic. Parker stated that he believed that if Dean were in fact participating in illegal activity, he was not doing so in his presence. When confronted about the credit cards and the FTC charges Parker denied utilizing any GCIC/NCIC or departmental records for illegal activity.

**H. Employee Information**

Malik Parker was hired by the Roswell Police Department on September 5, 2017. On the date of the incident, Parker had 1 year and 10 months of service with RPD and was assigned as a Communications Officer in the 911 Center on D Squad. In his 2018 performance evaluation, Parker has rated as "Highly Successful" and had no previous disciplinary action.

A review of the Formal Investigations Complaint file revealed that Parker had no prior FI Complaints.



**ALLEGATION NO. 1: The Department alleges that on July 10, 2019, Communications Officer Malik Parker, while off duty, was arrested and charged with Possession of Marijuana with Intent to Distribute and Conspiracy to Violate the Official Code of Georgia Annotated.**

When Clayton County Police Officers detained Communications Officer Malik Parker, he was driving a vehicle which contained a significant amount of unburnt Marijuana. Parker's front passenger, Jarontae Dean, was the target of a Narcotics Investigation and a long-time friend of C.O. Parker. Parker made statements, which eluded to the fact that he knew that Dean and the other occupants of the house were involved with criminal activity. It is clear that Parker knew or should have known that his relationship with Dean and his involvement in the events,

which occurred on July 10, 2019, would adversely affect the efficiency of the Department and destroy the public trust in him as a public safety employee.

Based on the preponderance of the evidence, it is recommended that **ALLEGATION 1**, be classified as **SUSTAINED**.

DETAILS: On 07/10/2019, at approximately 1400 hours, detectives were conducting surveillance in preparation for the search warrant planned to be executed at 6369 Havenridge Drive, Riverdale, Clayton County, Georgia 30274. While conducting surveillance, we were contacted by the suspect, Mr. STEPHENS, in reference to his supplier. Mr. STEPHENS advised that his supplier was on the way to bring him to his residence so he can have "reup." Mr. STEPHENS advised initially going to go to Cleveland Avenue in Atlanta, Georgia, to retrieve it, however; instead, his supplier would bring it to the residence.

At approximately 1435 hours, a white in color Dodge Charge pulled up to the residence, occupied by two black males. Det. WADE informed me that the front seat passenger got out the vehicle with a black in color bag. At approximately 1445 hours, the Clayton County Police Department- Narcotic's Unit and S.W.A.T. Team executed Search Warrant: 2019SW53078 at 6369 Havenridge Drive, Riverdale, Clayton County, Georgia 30274, in reference to this on-going drug related investigation. Once SWAT declared the residence safe, the Clayton County Police Department- Narcotic's Unit processed the residence for all evidence and located the above mentioned exhibits in the above mentioned areas.

While detectives were processing the scene, Officer BAKER conducted a free-air sniff with his K9 partner ODIN on the white in color Dodge Charger, at which time Officer BAKER advised K9 ODIN positively alerted to the presence of illegal drugs/narcotics inside the vehicle. Det. WADE was able to obtain a search warrant (2019SW52984) for the vehicle (see his supplemental report). Lt. ARNOLD contacted Rosewell Police Department since we located items belonging to them inside the vehicle, and Lt. ARNOLD informed me that Rosewell Police Department wanted us to place their items into evidence.

There was \$200 (\$50 SN: MA14071571A, \$50 SN: MD92376211A, \$50 SN: MF64631354A, \$50 SN: MB15767842A) of Clayton County Police Department- Narcotic's Funds that was utilized on a control buy this date located inside the residence


and recovered. The money was returned to the county funds. Photographs of the recovered money are attached to this case file.

The driver, MALIK PARKER, of the vehicle was arrested because the suspected marijuana was taken out the vehicle. The marijuana was taken out and clearly visible and recovered as marijuana. While Mr. PARKER did not directly get involved in the drug distribution, he was actively participating by driving the suspected drugs around to the sell location.

The front seat passenger, Mr. JARONTAE DEAN, was arrested because he took the suspected marijuana out the vehicle, and he was in close proximity to the marijuana once the execution of the warrant took place.

The evidence was processed as evidence the same day, and Det. REYNOLDS transported it to evidence. Det. ROBERTSON located all the items related to the fraud/forgery, and she advised she would obtain warrants on their cell phones and continue the investigation pertaining to those two crimes.

- P: I am currently a Communications Officer. I've been with Roswell since I believe August of 2017.
- R: Ok what shift are you on?
- P: D-squad.
- R: Ok. Alright so just tell us what happened.
- P: This is the complete and honest truth on July 10<sup>th</sup>. My brother-in-law contacted me, he gave me a call. He told me... he asked me to take him to a resident, which is his friend's house. I said ok. Again, I was actually on my way to work; I had my work apparel in my vehicle. I said no problem because, again, I wanted... he was going to give me gas... He told me he was going to give me gas money for the ride. He asked me to drop him off at this location. When he got into my vehicle he had my nephew, which is a 6-month infant, with him and a big black uh you know that you carry
- R: Car seat?





P: Car seat, yeah. Gets in my vehicle. I you know didn't smell anything, didn't think nothing of the latter other than I was taking him to his friend's residence. Get to that location. He gets out of the vehicle. He tells me hey, hold on one second, I'm going to go in here real quick, I'll be right back. Again, I am... I was informed that I was going to be dropping him off. I at that time told him, hey, I'm on my way to work. Well I was actually on my way to a haircut cause it was about 2:00 p.m. but then I was going to be heading to work but you know so time management, so I needed to... I was in my way to work. Hurry up man, you know, hurry up. The only reason that I did not leave when he immediately got out of my vehicle was because he left the infant in my vehicle, my nephew was in my vehicle. At this point, again, I'm thinking nothing of any suspicion, nothing's out of the ordinary. The reason I'm thinking nothing is out of the ordinary he's asked for things similar; rides not only to you know this friend's house, his residence, his personal residence where his mom lives. He doesn't have a vehicle. You know, and again, my nephew was with me so I did not think any criminal nature was going on at this time. We have a six-month baby in the back seat of my vehicle. The next thing I know... And, I'm being honest with you guys, I have been to this residence before. And again, nothing seemed out of the ordinary. These people are not... I'm not going to even lie to you guys and say they're exemplary of conduct. And when I say exemplary of conduct, not that I believe them to do anything illegal, I just... they're, they're family you know and that's basically all I can say. I definitely was to a point where I had gotten too comfortable; I will admit that. I had gotten too comfortable around the people that I was around because, again, I thought nothing out of the ordinary. The next thing, while I'm at this residence, the next thing I know is I see a police presence. They swarmed the residence. Again, I was in my vehicle with a six-month infant. Never on this date did I enter that house. I did not enter that house. I sat in the vehicle in the driveway. I was... this happened within not even maybe a little bit over five minutes, if that long. That's how quick time was progressing. It wasn't a long time that I had been waiting outside. I had no knowledge of what was going on inside the house, what type of behavior or what they were involved in. I genuinely did not know. I thought these two are friends and I thought I was taking him to his friend's house. I was arrested. They charged me with possession of... For what was found inside of the house. Not only was I charged with what was found inside of the house, there was nothing on my person. There was nothing in my vehicle. But I was charged with what was inside of the house and I had not been inside the house and that is, you know, the situation that's at hand.

R: Ok. So he's your brother-in-law?

P: Yes.

R: So... And what's his name?

P: Juran Tapian.

R: Ok. And so where did you pick him up at?

P: I picked him up from his house, from his residence which is literally down the street from our.

R: Ok and then he said... Asked you to go to his friend's house.

P: Drop him off at his friend's house.



R: His friend's house. You've been there before?

P: Yes.

R: How many times have you been there?

P: Not over five times, if that many. Not many.

R: Over the course of how long?

P: Maybe a month of so. Maybe not... Maybe two months maybe.

R: So five times over the last two months.

P: If that, yeah, if that long. Yes.

R: Ok. Have you picked him up before at his residence?

P: Yes.

R: Are you typical for this? You pick him up at his residence and you drive him to this house and you drop him off? Or what's... Over those five times why did you go to this house?

P: Dropping... Yeah it was never by myself, always with him. Never by myself. Never have I gone over there by myself and yeah he said just to drop off him off. Like I said, he doesn't have a car and this is a family member. I don't know you know, what you know personal thought processes are or anything like that, but it's not out of the ordinary for me to give someone a ride this... You know it's not just him, I've given other family members rides before and again, that is why my thought train wasn't hey, this guy might be involved in something illegal or anything like that. This is why and this is just me being honest. If I'm you know... I'm sorry go ahead... You know like I said, I was... I, I, I had gotten too comfortable. You know and I understand completely how it reflects on the department and you and I'm very apologetic for that. I am so confident in, and not overly you know confident... I'm confident that my charges are going to... They're going to understand the error that was made and you know I'm going to get my charges dismissed. I'm confident in that. Right now, I'm probably talking too much, but I'm sorry.

R: You share what you want to share.

P: Right now I haven't even, I don't even have... I haven't even... You know we get paid Friday. I don't even have the money. I haven't even retained an attorney as of yet. Officially I haven't at all. You know if I was involved in any type of drug dealings or anything like that I'm positive I would've already been able to retain a lawyer you know. I wouldn't want to keep my job. This is a police department; I know where I work. Like I said I'm apologetic for how it reflects on the department, but again, it was a wrong place, wrong time situation. It genuinely was.

R: Just to back up and confirm, this is your wife's brother?

P: No, this is my wife's... They're like brother. They've known each other for years. This is her sister's boyfriend.

R: So your wife's sister's...



P: Boyfriend, yes.

R: How long have you known him?

P: Over seven, eight years now.

R: Ok.

P: If not longer.

R: Alright, was this the first time that the nephew was with you?

P: No. No. No.

R: And then who's house was it?

P: This is his friend's house. I don't... His last name is Stevens. I don't even know his real name. He has a nickname, an alias.

R: And...

P: But I don't know his legitimate name. I honestly don't know.

R: Ok but you said that you consider them family?

P: Not his friend.

R: Ok.

P: Not his friend, no. This is my, you know my brother-in-law. That I mean he is my family.

R: Ok you were saying you got too comfortable with him?

P: Yeah. Yes. Yeah, honestly. And you know...

R: You go ahead if you want to say...

P: No that's, no.

R: Ok. Have you ever gone inside the house?

P: Yes.

R: And when you've gone inside the house have you seen anything before of any type of criminal activity?

P: No. When I've gone inside the house for one it's been very quick natured; very quick. Nothing of hanging out or anything like that. It's always been ten minutes or whatever. Again, I've met this guy, the, the household or the person that lives at this residence; I've met him through my brother-in-law. I've you know, seen him at other locations, not just his home. You know bar-b-q's, family get-together's and things of that nature but again, I don't know him personally. I don't. I genuinely don't.

R: Have you hung out with him before?





- P: No. No hanging out, none of that. The only person that I spend any dealings with was my brother-in-law and that's how I know that guy. That's how you know I was introduced to that guy.
- R: So you said that you were charged with the items that were inside the house?
- P: Yes.
- R: And there was nothing in your car?
- P: Nothing on my person; nothing in my vehicle. No.
- R: Explain to me then why a K-9 would hit on it?
- P: No clue. And I mean... Well I have to be honest with you, from whatever he might've had in my vehicle, I'm not sure how the K-9 operates, but again, nothing was found in my vehicle at all. I know that for a fact. They left my vehicle at the scene of the um... of the uh... where it... where they went in or whatever. They left my vehicle. If it was anything in my vehicle I'm sure they would have towed it you know. I'm not abreast on all of the situations but there was nothing in my vehicle at all. You know he was in my vehicle. The car seat was in my vehicle. That's it.
- R: At any point have you ever possessed, sold, purchased...
- P: Used.
- R: Marijuana, any other drugs?
- P: No, no I have not. No. No. I have not.
- R: Do you know what it smells like?
- P: Yes.
- R: So there was a couple thousand grams, from my understanding, found. Right?
- P: Yes.
- R: And, from my understand, this bag contained the marijuana that he had. Is that... What's... Do you know anything where it was at? Or what...
- P: Like I said when he got in my vehicle he had a car seat with him. That's all I saw. When he got in my vehicle I legitimately did not smell anything; I wouldn't have let him in my vehicle smelling like marijuana. Because I know if I get pulled over I'm liable for what's in my vehicle. I would not have done it, especially not with a six-month old in my vehicle as well. It just would not have happened. Again, like I said, when he got to my vehicle, when we got to this residence he left the child in my car. He got out of my vehicle and went inside the house. That day I did not go inside the residence so I don't know you know... I didn't smell... Of course not. I was you know in my car. I didn't smell anything of course what was in the house, no.
- R: So when he got into the car all he had was the car seat?
- P: That's all...



- R: He didn't have anything else with him?
- P: I'm going to be honest with you, I didn't search him. I didn't... I wasn't you know hey, let me pat you down or anything like that. That's you know not you know... Honestly, I didn't. But I didn't... There was no conversation that he had anything with him when he got into my vehicle.
- R: Have you ever suspected Mr. Dean for being in connection with any drugs before?
- P: No because, honestly, I don't ask those questions. I don't care to know what he does in his personal life. Like I said, yes he is family. Yes I have, you know, we've done family things together, but it's not like I'm just hey, let's go get drinks together or nothing like that you know. You know we're family through that... in that aspect but we're not going out and just hanging out.. hey, what are you doing tonight or anything like that. It's just... it doesn't happen.
- R: There was also an issue on the scene with several credit cards or financial transaction cards being found. What...
- P: Everything that I had when I got arrested, they gave me all those cards back. And they all had my name on them. The cards had my name on them. Whatever else... Again, this isn't like... Again it's nothing... I don't... There was nothing else that I mean there's nothing that I'm involved in in any type of way, any shape or form. You know what they had going on in that house is what they got going on. It's not... It's not in my possession, nothing like that. Nothing you know...
- R: So they took several cards out of the car while they were searching it, correct?
- P: They say, yes.

I don't know if my vehicle was broken into once they left it there. They won't even tell me what they took out of my vehicle. I know for a fact that there no drugs in my possession. That's how I know that there were no drugs in the car; no drugs on me. None, whatsoever. I... I lost my train of thought. What was your original question again?
- R: I'm asking the questions about the credit cards basically that were found. They pulled them out. They pulled some out of the car.
- P: The credit cards that were pulled out of my car had my name on them. They were actually given back to me once I got released. It was you know in my property.
- R: So to your knowledge there was not any other cards they found in the house with your name on them or anything like that?



- P: No. No. No.
- R: Do you know if your information, your name has been used for any reason to make any kind of fraudulent cards?
- P: Not to my knowledge. I wouldn't think so. I would hope not. I didn't even consider that. I didn't even think about that.
- R: At any point at any time have you ever had any kind of drugs, marijuana, other narcotics in your vehicle?
- P: No. No.
- R: Has anybody had them in there before and you've said hey, you can't get in my care or something?
- P: Honestly no. No. Nobody's... Not even hey you can't get in my car with weed in my car. No. Again, not to my knowledge, which is you know and I know that's not a great answer but again, no. No.

- P: No, no. Not at all. No.
- R: Do you understand why I'm asking those questions though?
- P: Yeah because it's, it's... Yeah, I would ask the same questions, honestly... I...

- P: Ok.

- R: That's all I have.
- T: So you said you've know Dean for like seven / eight years?
- P: Yeah, roughly.
- T: What is it that Dean does for work? What are you know?
- P: From what I know he had a job at one point. Other than that I don't really know. I honestly don't know.
- T: You say he had a job at one point, what does that mean? Like...



- P: Well he was working I think like at a warehouse or something like that and I mean you know... I don't know exactly what he does for a living. My guesses are, of course, now that it's not the best. It's probably not even legal – whatever he's doing. But again, you know that's...
- T: How long would you say, out of the seven or eight years that you've known him, how long would you say that he worked at that warehouse?
- P: I don't know maybe a year, maybe. Maybe a year. I, you know.
- T: Here's the thing, I get what you're saying like you know brother-in-law ya'all have that relationship there, but outside of that ya'all aren't friends. Ya'all don't hang, you know what I mean? Like it's just kind of family things here and there, I get it. And he's his own man and you're not intimately knowledgeable about what he does as far as a living. Like you don't know exactly what time he clocks in and clocks out of work. I'm just saying would you agree that if you know somebody for seven or eight years you would have an idea of whether they actually keep a job or they worked at this one place? I'm sure you would know, considering what it is that you do.
- P: Yes.
- T: I'm sure you're known around the neighborhood with people who probably don't have that type of relationship with you, they know that's the guy that
- P: Yes.
- T: He's a straight-up dude. He's in law enforcement. That type of thing. You know what I mean?
- P: I try to keep my business to myself as well, but yeah.
- T: But I mean so having said that, would you... that's the reason why we asked you what was your impression of what Dean did for work. Cause on the flip-side of that coin if you've known this guy for seven or eight years and you can't say what he does for work...
- P: Probably shouldn't have him in my vehicle.
- T: Well I mean you know, whether you have him in your vehicle or not that's totally your decision. But I'm just trying to understand the um... Again, the at minimum, some suspicion should have been there as to what it is that he does. And that's what I'm asking you. Did you have any suspicions at all what he did? Or...
- P: Honestly, yes. I mean I didn't know exactly what he did because I didn't want that knowledge. You know I don't want that knowledge. So minimum, yes. But you know, again, this you know this is...
- T: So and again, basically I mean with you being in law enforcement, this is your brother-in-law, so more so you're not explicitly coming out and saying hey man, do you sell drugs? But at the same time, in the back of your mind, you suspect that he may. And I'm not trying to put words in your mouth, I just trying to... I'm trying to relay to you the question that I'm trying to ask and help you understand what it is that I'm asking. Because when I ask you if he works or what he does for a living it seems like you're getting the impression that I'm looking for exactly what the man does for a living, like what is his job title, where does he work, and



that type of thing. And that's what I'm going for. What I'm going for is did you have any suspicions that he sold drugs? And then you were saying that you were... I guess it wasn't out of the ordinary for you to pick him up. Like he called you us, hey Malik can you take me over here and drop me off at my friend's house, this and that. And you said that it wasn't out of the ordinary, that you would like pick him up and drop him off places, run him around, that type of thing.

P: Not often, but it has happened before. But I get a call hey Malik can you drop me at the barber shop? Can you drop me at the grocery? Can you take me to the grocery store real quick? And it's not just him, there are other members of our family with the exact same dynamic. From grandmothers to you know other people. They just don't have cars. So hey you know I got a car. You need something real quick, I don't mind taking you to this place. You need to be at the community center at you know... You know this isn't... And I completely understand the line of questioning. I get it. But this isn't out of the ordinary is what I'm trying to get you guys to you know understand. It's not. Can you take me to the bank and drop him off at you know take him to the bank. Can you take me here. Whatever.

T: So when you would take, and specifically we're talking about Dean. I guess his nickname is Teddy, right?

P: No it's Junior.

T: Junior?

P: Yeah, Junior from what I know.

T: Ok. So specifically when we're talking about Junior when you would take him places, if he does ask you, hey drop me off here or can you run me over here really quick, did you ever suspect at any point that he was maybe making a transaction?

P: No, not at all. Genuinely, no. And I wouldn't be a part of it if I did. I wouldn't want to be anywhere near that if it was, if that was you know was happening. I don't want to be a part of it. I wouldn't want to be a part of it. I know what I do for a living. Ya'all know what I do. I'm not... You guys, I don't know if you guys have pulled my background. I've never been arrested, never been questioned by the police. Any of that. And that's not just... That's because I'm uninvolved in anything illegal. You know I've worked for another agency for years.

T: The... So when you said now if you were taken him somewhere and dropping him off and, like I said, hypothetically speaking, if you're taking him somewhere and you're dropping him off he's making a quick transaction and he's coming back, you take him home or drop him off wherever you need to go. You said you wouldn't get involved in that at all. If you knew...

P: If I knew it was drugs, that's a no.

T: If you knew that that's what he was doing.

P: Yeah, no.

T: And you're not the one... You wouldn't be the one doing it; you wouldn't be the one actually making the sale so why wouldn't you... Why would you have a problem with that?



- P: Cause I don't want to be involved in anything drug related so I...
- T: So again, I guess having said that, if you had suspicions that he could possibly be dealing in drugs and I guess living that life style and you saying that you didn't want to be involved in anything like that then why would you continue to have that type of relationship with somebody you felt that was... I mean not only living that life style but then jeopardizing your life style by possibly getting you involved in that?
- P: The question is why was I dealing with him? It's simple as this is family you know. And not... And I know... You know I don't want you guys to take that... you know it's... I genuinely didn't think that he was doing anything illegal on you know when I was dropping him off. I just didn't. You know this is... I genuinely didn't think that. I'm taking him hey, drop me off at my friend's house. Cool, boom. Dropping you off. And that was it. That's my thought process. I wasn't thinking that he was hey I'm going out here to make a drug sale or play or whatever; that's not what I'm thinking. I mean as a you know favor to my wife you know I give family members rides or whatever. But I you know not thinking that I'm getting involved in drugs or anything like that, so.
- T: Have you ever personally witnessed any drug activity? Any dealings? Any transactions?
- P: No.
- T: Anything drug related, whether it be at the residence that you were at that day?
- P: No.
- T: Or involving with I guess your brother-in-law Junior?
- P: No.
- T: No? Did you ever have a conversation with Junior and ask him just straight up? Like listen, whatever it is that you're into I don't want to be a part of it. Did ya'all ever have a conversation like that?
- P: No.
- T: No?
- P: Not me just saying hey... No. No.
- T: Did um... Cause like you said, if this is your wife's sister's boyfriend. Did you ever relay any of those feelings or anything like that, any of that energy towards your wife to like hey you know I don't know what Dean's up to but if you could talk to your sister maybe you don't have that around us or that type of thing?
- P: I man... Somewhat to an extent as far as hey, you know, whatever anyone is dealing with illegal or whatever, keep that away from me and my family. Of course. But not specifically just hey you doing this or I don't want to be... Because I didn't just think hey he's doing whatever. That just wasn't my thought process.
- T: And I know you keep going back to it about you know again, this is your brother-in-law and ya'all have that relationship which, I mean we can't pick our family, right? The concern for us is that the agency comes in when there is this improper relationship that you were to have with someone who is dealing in criminal aspect, whether it be drugs, the financial card transaction, anything of that nature. So you can minimize



your exposure to that family, like you said. I mean if we're going to a family gathering you can't help whose going to be there. But in this situation we have you... I mean what it amounts to making to a delivery. And you know when you use this, this that well he's a family member, I didn't ask questions. It's just hard to digest, especially being in the position that you're in. You know you work here at the police department. You have access to information. I mean essentially you have a security clearance that most people don't have. So would you be.... Would it surprise you if uh... Well I'll say this, there's some concern with the GCIC information. I'll just leave it at that.

P: You say with mine?

T: Yeah, with your... With your... With the GCIC. With you and GCIC. There are some issues there. And there are definitely some concerns from the department side of it. But uh... I'll leave it at that.

R: What kind of relationship do you have with Dean? I mean before this incident?

P: Family I mean.

R: Alright but I mean... Ok what I mean is... So I have family, I have brothers-in-law, right? I see them, I talk to them, but I honestly couldn't tell you their birthday. Couldn't tell you their favorite color. Then I have another brother-in-law I have a much more intimidate relationship with him. What was your relationship like with him?

P: Not intimidate. Somewhere in between. I mean partially in between honestly. I don't know his birthdate, don't know his favorite color but that's about it.

R: Right, how often do ya'all speak?

P: Speak, maybe once a week. Maybe once ever two weeks. Something like that.

R: Phone, text, in person?

P: Not really text, phone call.

R: How often did you give him a ride? How many in a week, in a month?

P: In a week?

R: Yeah, just how many times have you given him a ride?

P: Maybe twice in a week. Maybe twice, if that. Not even that. Maybe once a week. It's not like a regular occurrence, so. One or two times.

R: And was it always... How many times was it going somewhere other than this person's house? Like did you most of the time was it to run an errand or go to somebody else's house, or specifically the house where the incident happened?

P: The, the...

R: Where all did you take him and how often were you taking him to these places?



- P: Like I said, not often. Blue moon I've taken him to that house before, to the grocery store, to other family members houses.
- R: And how often were you taking him to other family members houses?
- P: Not often, I mean if he needed a ride. A lot of times his... My sister-in-law picks up my children from school. My children go to the daycare that my sister-in-law works at; that's his girlfriend. So there's a lot of you know travel involved in that because a lot of evenings she'll pick up my kids and watch them until you know either my wife can get off work and get them or I can get there and get them. Whatever the case can be. So there's a lot of traffic in that and that's where most of our communication comes from because you know I might have to you know get my nephew sometimes. My wife gets the nephew; my wife gets the kids, whatever. So it's a lot of traveling communication in that. And that's another reason why you know, they watch our kids a lot, so that's another reason why I don't... Hey you need a ride here? Why yeah, sure, why not. You know you're watching my kids often. So you know that's the thought process that goes into it.
- R: Is there anything that I have not asked or that you want to say that might be relevant to this investigation?
- P: No.
- R: This is a confidential and ongoing investigation. You are hereby ordered not to discuss this interview or any aspects of the investigation with anyone other than the assigned Internal Affairs investigators; Detective Ross or Detective Robinson or Captain Charles Greco, Commanding Officer of OPS, or the Chief of Police. Failure to adhere to this order could result in an additional charge of insubordination against you, which could result to your dismissal from your position with the Roswell Police Department. Do you understand this order?
- P: Yes.
- R: The department and the City of Roswell has a zero retaliation policy. Failure to adhere to this may result in severe disciplinary action up to and including termination. The time is now 2:42 p.m.. This concludes the interview.

Captain Greco,

Det. Ross also request the information so I just decided to send it in one email.

The call original came into the 911 center. It was answered by a trainee (Amanda Miceli) who was being monitored by Stephanie Jones. They were advised by the subject on the phone that they had a Roswell dispatcher in custody and need to talk to a supervisor. Stephanie advised Supervisor Terry O'Connell who told her to get me ( I was in my office). Stephanie walked into my office and told me. I advised her to give the person my desk number and call me.

I spoke with a Lt Arnold, Clayton County Narcotics, who said that he had Malik Parker in custody. He told me the charges were conspiracy, possession w/ intent, and credit card fraud. They served a search warrant at the address and located 5lbs of marijuana (I did not get the address). He told me that Malik did not live there and gave me the case number of 1903-3600. He said that he had his uniform and ID and him and wanted to know if we wanted to come get it or have it put in evidence. (I spoke with you about this and called him back to have him put it in evidence)

Just after I disconnected, Captain Ratliff and Deputy Chief Rivard were notified. I also notified Melissa Alterio by phone.

I spoke with all the shifts that week and told them that Malik Parker was arrested in Clayton County and that he will be placed on Admin leave. I also said that it would be an investigation within OPS also. I recommended them not to talk about it and if they had any questions they could direct them to me. Before I spoke with D Squad, Terry O'Connell said that Molly, Malik's Wife, had called Whitney and that she already knew. (This was the day it occurred). At this point, I am unaware if anyone spoke to Malik. I have not spoken with Whitney as of this email but I did confirm that there was not contact with his direct Supervisor, Michelle Schneider.

I will update you if I hear further. I attached the original recording that came into the center.
