On 10/20/2024, I was notified to call Jonathan Brandreth in regards to a complaint he wished to make against Sgt. Fulenwider, who was working an extra job at Northside Cherokee Hospital. I activated my body worn camera (BWC) and called Jonathan. Jonathan alleged that Sgt. Fulenwider was not pleasurable to deal with, when asking him to "not tow his vehicle" from the front of the hospital. Jonathan described Sgt. Fulewider to be an "asshole", and that Sgt. Fulenwider said "If you're looking to fight someone, I'm the fucking one." Jonathan believed Sgt. Fulenwider was getting too close to him, wishing to "fight him". He explained how he didn't feel comfortable with his interaction with Sgt. Fulenwider, believing that Sgt. Fulenwider was trying to instigate a fight, while wearing "a vest, gun and taser". Jonathan called Canton Police Department, and spoke with Sgt. Lilley. Sgt. Lilley explained how he wasn't able to handle the situation because he is with Canton PD and wasn't at the hospital when the incident occurred. Jonathan wished for me to review Sgt. Fulenwider's BWC footage.

I reviewed Sgt. Fulenwider's BWC footage, labeled SO24-014476 (two separate videos). I also spoke with Sgt. Fulenwider about this situation. After having done so, I called Jonathan. This conversation was recorded on my BWC. I explained to Jonathan that I had reviewed Sgt. Fulenwider's BWC and didn't believe there to be any violations of policy. I explained numerous times how I believed there was confusion between the two, even providing an example to try to bring light to Jonathan that he was being told to do something by a law enforcement officer, but choosing to ignore the orders. I explained how I planned to talk with Sgt. Fulenwider about the situation; however, Jonathan was not satisfied with that. Jonathan wished for Sgt. Fulenwider to receive some form of disciplinary action for his actions of being a "dick" and an "asshole" and for trying to "fight him". I informed him I would forward this allegation up to the appropriate people.

Having reviewed the BWC of the incident, and having talked with the complainant and with Sgt. Fulenwider, it is my belief and recommendation that the allegation in this incident be closed **UNFOUNDED.** However, the complainant requested a further look into this incident. Therefore, I am forwarding it to Sgt. Fulenwider's current Precinct Commander, Lt. Christopher Bryant.

On October 20, 2024, Sergeant Lyvers received an allegation on Sergeant Fulenwider from Jonathan Brandreth; the basis of the complaint falls under Sheriff's Office Policy #01-03-02 Code of Conduct; F; 6 (Courtesy). Sgt. Lyvers conducted his own investigation into the incident and found the allegation UNFOUNDED. However, upon contacting Mr. Brandreth, he was not satisfied with the findings; the complaint was forwarded to me for follow-up. Below is a synopsis of the interaction between Sgt. Fulenwider and Mr. Brandreth:

Prior to Sgt. Fulenwider's body camera being activated, Mr. Brandreth can ne seen at the emergency room triage desk with a female; Sgt. Fulenwider can be seen in the hospital security office sitting. Mr. Brandreth can be seen speaking with Sgt. Fulenwider, then exiting and returning to the tirage station. At or around 2000 hours, Mr. Brandreth can be seen entering the vestibule, stopping, and looking intently at Sgt. Fulenwider, and raising his arms from his side in what appears to be an expression of displeasure. Sgt. Fulenwider exited the security office and spoke with Mr. Brandreth; this interaction is captured on his body worn camera.

The body worn camera footage begins with Sgt. Fulenwider asking Mr. Brandreth if he had an issue to which Mr. Brandreth inquires if Sgt. Fulenwider is having a bad day. Sgt. Fulenwider states to Mr. Brandreth to "go move your car and get out of my face." Sgt. Fulenwider then instructed Mr. Brandreth to move his car several times to which he inquired if Sgt. Fulenwider was "insane." Mr. Brandreth then stated in a condescending manner "you're having a bad day" and another disagreement ensures regarding their initial interaction, followed by a back and forth related to Mr. Brandreth's winking at Sgt. Fulenwider. Following this, Sgt. Fulenwider stepped towards Mr. Brandreth and stated, "if you want an issue with me, you came to the right guy." Sgt. Fulenwider attributed this statement as a tactic to direct Mr. Brandreth out of the waiting room and away from patients. Mr. Brandreth returned to his car and stated while walking away that he was calling a supervisor; during the video I was unable to see any physical contact, or vulgarity from either party.

Following their initial interaction, Sgt. Fulenwider's body camera recorded a secondary interaction with Mr. Brandreth on the sidewalk in front of the emergency room. This recording consisted of Sgt. Fulenwider attempting to give Mr. Brandreth a business card, and Mr. Brandreth insisting he place it on the ground as he talks on his cell phone. After both attempt to talk over one another, Sgt. Fulenwider stated "if you're going to be a belligerent idiot, you're going to have to leave." After another back and forth between the two, Mr. Brandreth's abruptly ends their conversation with the statement "the cops are coming" and walks off. The

body camera footage continues for several minutes, however, there is no other interaction between Sgt. Fulenwider and Mr. Brandreth.

After reviewing body-worn camera footage, hospital security camera footage, and a statement made by Sgt. Fulenwider, I find no evidence that Sgt. Fulenwider used vulgarities or challenged Mr. Brandreth to a fight, nor any suggestion that Sgt. Fulenwider used his "vest, gun, or taser" as a tool for intimidation. Therefore, I recommend this allegation be closed UNFOUNDED.

On October 24, 2024 I contacted Jonathan and informed him of my findings for this allegation. This conversation was recorded on my body camera.
