Circumstances Leading to Use of Force

On August 1, 2023, Lt. Keith Powell requested emergency assistance while on a traffic stop at 6350 Lake Oconee Parkway (Publix).

Upon arrival, Lt. Powell had already requested an additional unit for transport. While awaiting the transport unit, Lt. Powell allowed the offender, Stanley Jones, to make the necessary arrangements as so his vehicle could be retrieved by a family member or friend, in lieu of it being towed. Lt. Powell allowed Mr. Jones to do this without being restrained in handcuffs. While Mr. Jones was talking on his cell phone, Lt. Powell attempted to speak with him at which time Mr. Jones began shouting profanities at him. Due to this sudden and aggressive behavior, I instructed Mr. Jones to get off of the cell phone and put his hands behind his back. As I attempted to grab Mr. Jones left arm, he pulled away from me before pushing into me with his right arm and shoulder. Mr. Jones was then assisted to the ground where he continued to physically resist and disobey commands. A shoulder pin technique was utilized, but proved to be

Circumstances Leading to Use of Force

During the course of a traffic stop, the odor of marijuana was detected coming from inside of Mr. Odister's vehicle and he was instructed to stand at the front of his vehicle as so a vehicle search could be performed. Mr. Odister refused to stand where instructed and was warned that if he did not comply that he would be arrested. Mr. Odister then began walking towards the driver's door (instead of forward as instructed) and was staring intensely at the front driver's seat of his vehicle (driver's door left partially open by him when exiting the vehicle previously). In order to prevent flight and/ or a potential assault due to not knowing what was inside of his vehicle, I grabbed Mr. Odister's left hand so that I could place him in handcuffs at which time he pulled his hand away from me and began backing away from me.

Mr. Odister was instructed multiple times to get on the ground to which he refused every time. Mr. Odister was also warned several times that if he did not comply with commands that he would be tased, however he still refused. I then deployed my TASER-7 ECD and the probes struck Mr. Odister in the abdomen causing him to fall to the ground and appearing to be effective. However, Mr. Odister regained his footing and began snatching the probes from his body while fleeing on foot across the east bound lanes of Interstate 20. After verifying that traffic was stopped, I pursued Mr. Odister into the roadway and again

Circumstances Leading to Use of Force

On 05/11/2022, Deputy Cowdrey conducted a traffic stop on I-20 at the 132 mile marker westbound for a window tint violation. After explaining to the driver (Daguan Kinloch) the reason for the traffic stop. Deputy Cowdrey instructed the driver to stand at the front of his car. This was due to a strong odor of marijuana coming from inside of the vehicle and a vehicle search was about to be conducted. Dispatch relayed to Deputy Cowdrey that the driver had an active warrant. Deputy Cowdrey attempted to detain the driver by placing him in handcuffs. As Deputy Cowdrey placed one handcuff on the drivers left wrist, he physically resisted by pushing and pulling away before running to the drivers side door of his vehicle. Taser ECD was deployed, striking the offender in the back but was not effective. The offender was successful in opening the drivers door of the vehicle and entered the vehicle in an attempt to flee.

Offender continued resisting and began kicking at Deputy Cowdrey at which time the Taser ECD was cycled again. While attempting to remove the offender from the vehicle, he attempted to remove the taser from Deputy Cowdrey's hand. Offender gained his footing, during the taser cycling, and fled toward the wood line. Deputy Cowdrey gave chase and the offender surrendered in the wooded area without further incident.
