Kyle,

I submitted this request according to state law. The request was made to you, in your official and individual capacity. I suggest you not put your personal assets at legal risk. There is no investigation, the man is dead. Release the body cam to me or a judge will order you to! This is also a potential civil rights violation under Near v. Minnesota.

I will file a formal complaint with the AG if you have not fully cooperated by Friday 2.28.25.

## Legal Issues with Requiring U.S. Mail for Open Records Requests

Forcing requesters to submit public records requests only via U.S. mail is a barrier to access and may violate Louisiana's Public Records Law (La. R.S. 44:1 et seq.).

# **Key Legal Considerations**

- 1. Louisiana Public Records Law (La. R.S. 44:1 et seq.)
  - The law states that "any person" has the right to request public records without unnecessary barriers.
  - Agencies must provide "immediate" access to records if they are readily available.
  - The law does not specify that requests must be submitted only by mail, and many agencies

accept email, fax, or in-person requests.

### 2. Attorney General Opinions & Court Rulings

- Louisiana AG opinions have emphasized that agencies must facilitate, not restrict, access to records.
- Courts have ruled that imposing arbitrary requirements (e.g., requiring physical mail) can violate open records laws.

### 3. Federal Considerations (if applicable)

- The First Amendment protects the right to petition the government, and excessive restrictions on public records access could impede transparency.
- If **federal funds** are involved, **Title VI** and other **federal regulations** may prohibit barriers to public access.
