NARRATIVE

22-183059

On 07/27/2022 at 2045 hours I, Deputy Gaiter, conducted a traffic stop on the 600 block of E Boundary Street for failure to dim headlights. The driver of the vehicle La'Edward Williamson opened up the door and got out of the vehicle. I advised Mr. Williamson to sit back down in the vehicle and he began running west on Watkins Street. Mr. Williamson then ran north on Sibley Street and jumped a wooden fence. Mr. Williamson was taken into custody at the corner of E. Boundary and Walker Street. Lt. Hitchcock A11 located two red plastic cases in both of the pockets of Mr. Williamson's shorts. I looked inside of the plastic case and one of the cases had a empty plastic bag with a white residue. The other case contained a small plastic bag with a white powdery rock substance. I weighed the white powder substance and it weighed approximately .01 grams. I also field tested the substance and it tested positive for cocaine. The cocaine was filed under property receipt #509038.

GSP #786 arrived on scene and I advised him that Mr. Williamson had a strong odor of an alcoholic beverage on his person. His speech was also slurred and there was an open can of beer in the cup holder. Mr. Williamson refused to take any testing and he stated that he only drank 1 beer. Mr. Williamson was issued citations for driving while unlicensed, DUI refusal, no proof of insurance and failure to dim headlights. The vehicle was removed by the list wrecker Riverfront towing. The claim check was given to the owner of the vehicle on scene.

The incident was captured on BWC and warrants will be signed on the accused.
