### NARRATIVE

**22-211279**

On 08/31/2022 at 2129 hours I, Deputy Gaiter, was assisting with a safety check point at the intersection of Richmond Hill Road and Bungalow Road. Daniel Poole came through the check point and he appeared to be impaired. Mr. Poole was operating a Nissan Versa gray in color with a GA Tag#TBC4648 Mr. Poole was sweating excessively and his pupils were constricted. Mr. Poole pulled into a parking lot and he had his left hand clinched. Lieutenant Danko asked Mr. Poole what he was holding in his hand. Mr. Poole ignored Lt. Danko and refused to open his left hand. I entered the passenger side of the vehicle and Mr. Poole opened his hand and dropped a plastic cigar wrapper which contained two blue round pills. Mr. Poole was taken into custody and he was also issued citations. The pills were stamped M30 and I identified the pills through Drugs.com as Oxycodone. The tag that was attached to the vehicle did not belong and Mr. Poole's license were suspended and the vehicle had no insurance. Mr. Poole also refused to take a field sobriety test and he was placed under arrest for DUI refusal.

The pills were filed under property receipt #509566 and dropped into the drug locker. The vehicle was towed by GSP list wrecker. The stop was captured on BWC.
