#### **NARRATIVE**

### 22-222025

On 09/13/2022 at 1802 hours I, Deputy Gaiter, conducted a traffic stop on the listed vehicle for a seat belt violation. The front passenger Brandon Clinton was not wearing his seat belt. Mr. Clinton was wearing a fanny pack and he appeared to be reaching into the pouch. He was asked by myself and Deputy Tarpley to stop reaching into the pouch. Deputy Tarpley asked Mr. Clinton to step out of the vehicle.

Mr. Clinton stepped out and he grabbed the same fanny pack he was asked to leave in the vehicle. Mr. Clinton tried to run and Deputy Tarpley, Deputy Leather and I took him into custody after placing him onto the ground. Mr. Clinton refused to place his hands behind his back and he was trying to reach into his waistband. We were able to take him into custody and determined that he had active felony warrants. The incident was captured on BWC.
