**NARRATIVE**

On 10/25/2022 at 1940 hours I, Deputy Gaiter, conducted a traffic stop on the listed vehicle (2004 Cadillac Escalade blue in color GA Tag#RMV3376) at the intersection of Windsor Spring Road and Willis Foreman Road. The vehicle had a burnt out front driver side headlight. I made contact with the driver/owner of the vehicle Arthur Hill and he advised that the vehicle had an electrical problem causing the front driver side headlight to malfunction.

I ran Mr. Hill's driver license and Deputy Morton S2 arrived on scene and approached the front passenger side of the vehicle. Deputy Morton advised that he smelled the odor of marijuana coming from the vehicle. Deputy Birch S8 arrived and asked Mr. Hill and the front passenger Rodriquez West to step out of the vehicle. Both occupants of the vehicle exited upon request.

Deputy Birch located a small plastic container in the front center console. Inside of the plastic container there was approximately 54 grams of (4 individual plastic bags) marijuana wrapped in plastic, 29 grams of powder cocaine wrapped in plastic, and one round yellow pill stamped #230. Mr. Hill and Mr. West were detained. Mr. Hill was placed into the backseat of my vehicle and Deputy Morton placed Mr. West in the back of his patrol vehicle.

I walked back up to the vehicle and located a white garbage bag directly on the middle of the floorboard behind the front driver and front passenger seats. I opened the white garbage bag and it contained 16 bags of marijuana in a vacuum sealed bag. The approx weight was 470 grams.

Deputy Birch contacted the on call Narcotics Investigator. Sgt. Gould B25 advised to confiscated the listed vehicle and the \$550.00 in cash that was on Mr. Hills' person.

Deputy Leathers field tested the white powder substance and it tested positive for cocaine. I field tested the marijuana and it also tested positive. I identified the round yellow pill stamped #230 through drugs.com and the pill was identified as Oxymoron.

Deputy Birch read Miranda to Mr. Hill and Mr. West and they both agreed to speak to deputies. Mr. West said that the narcotics that were located in the vehicle were not his. Mr. Hill said that Mr. West picked him up in the vehicle that Mr. Hill was currently operating and that the drugs belonged to Mr. West.

The vehicle was taken to the Narcotics office and both subjects were transported to jail.

The \$550.00 was turned over to Sgt. Gould and filed under property receipt #500657. Mr. Hill blue Samsung Galaxy phone was also confiscated by Sgt. Gould. The 20 bags of marijuana were weighed by Sgt. Gould and weighed approx 514 grams and was filed under property receipt#500659. The cocaine was also weighed by Sgt. Gould and weighed approx 29 grams and oxycodone pill were filed under property receipt #500656.

The incident was captured on BWC and warrants will be signed on the accused. Mr. Hill was issued a citation for the defective headlight.
