**NARRATIVE**

**22-257984**

**On 10/29/2022 at 0205 hours I, Deputy Gaiter along with members of the Crime Suppression Team, walked through 302 6th Street (Maserati's) on a business check. We were checking the business because we received complaints of people consuming alcohol, drug usage and they do not have the appropriate license.**

**I walked over to the left side of the business and I made contact with a black male that was rolling marijuana into a cigar which was in plain view. I asked the subject, later identified as Larodney Walker (Arrested) what was he doing and I asked him for his identification. Mr. Walker backed up and ran on foot with the observed Marijuana. Walker ran out of the front door of the incident location. Deputy Leathers S1 and I told Walker to stop and continued to give verbal commands to lay down on the ground. Walker leaped a fence located directly behind the incident location at which time he threw down tow firearms on the other side of the fence which was observed by Deputy Leathers. Deputy Jason Mathis K3 advised that he observed Walker run back into the listed business through a side door which was being guarded by personal security at the business.**

**Deputy Leathers and I pursed Walker back into the business and began to search for Walker. As we walked upstairs to the second floor to continue our search, one of the owners said that no one went upstairs. Deputy Leathers entered an upstairs room and Walker was hiding behind a sofa and he removed his shirt that he was wearing. Walker was ignoring deputies and he refused to get up from behind the sofa. Deputy Leathers and I placed Walker under arrest without further incident. While I walked Walker to my patrol vehicle, Walker made a voluntary statement that he was rolling up marijuana when I made contact with him and fled because he was scared.**

**Investigator Hegg 508 located the two listed firearms directly where Walker jumped over the fence. One firearm located was a black and silver Smith & Wesson S9. The other firearm located was a black / brown Taurus Ultralight. There was also a cell phone located near the two firearms which was later determined to be Walker's as well.**

**Walker denied ownership of anything that was located and refused to answer any further questions regarding this incident. Walker was asked for his identity and gave a name of Sean Maddox with a date of birth of 11/03/1993 which later determined to be false information.**

**At the Jail, Walker was identified through fingerprints as Larodney Walker.**

I contacted Records Clerk Boutwell in the Records Division and requested her to run a criminal history on Walker. It was discovered that Walker was convicted of felony charges on 08/21/2015 in the Clayton County, Georgia Superior Court for the offense of Possession and Manufacturing Drugs.

The Smith & Wesson SD9 was filed under Property Receipt #514270 and the Taurus Ultralight revolver was filed under Property Receipt #514271. The located firearms were turned into the evidence locker located at 400 Walton Way, Augusta, GA. 30901

I applied for and obtained warrants for the listed charges against Walker. Walker was further committed to the Richmond County Jail.
