NARRATIVE

22-263577

On 11/04/2022 at 2151 hours I, Deputy Gaiter, conducted a traffic stop on the 500 block of Forsythe Street on the listed vehicle (2011 Hyundai Sonata GA Tag#CLU4199 gray in color). The listed vehicle had a burnt out rear passenger brake light. I made contact with the driver of the vehicle Dequila Jones.

While speaking to Ms. Jones I noticed that she was sitting on her purse and there was a rolled up marijuana cigar sticking from under the purse. I could also smell the odor of burnt marijuana coming from the vehicle. I asked Ms. Jones to step out of the vehicle. I detained Ms. Jones and placed her in the back of my patrol vehicle. I began searching her vehicle and located an open pack of Newport cigarettes in her purse. When Ms. Jones exited the vehicle she placed her purse on the front driver side floorboard. There was a small straw and a folded up dollar bill attached to the cigarette pack. I removed the straw and folded up dollar bill. Inside of the folded up dollar bill I located a small white powder substance. I located two more marijuana cigars on in the center console and one next the the center console. The cigars contained a white powder substance. I also located a cigarette in the drivers side door pocket and it contained a white powder substance. Corporal Mealing arrived and filed tested the white substance in the dollar bill and it tested positive for cocaine.

Ms. Jones said that she had cocaine on her person. Ms. Jones said that she stuff a bag of cocaine in her pants. Ms. Jones removed a plastic bag which had a white powder residue inside of it. The bag that she removed from her clothing was also very wet and greasy. Ms. Jones vehicle was left on scene and she was transported to the jail.

I weighed all of the items located in the vehicle and the combined weight was approximately 6 grams. I weighed the plastic bag that Ms. Jones removed from her pants and the approximate weight was 1 gram. The narcotics were filed under property receipt #514275. Ms. Jones was also issued a citation for the defective brake light. The traffic stop was caught on BWC. Warrants will be signed on the accused.
