NARRATIVE

22-274478

On 11/17/2022 at 1702 hours I, Deputy Gaiter, observed the listed vehicle (2014 Ford Focus white in color GA Tag#RSU3034) fail to yield while entering the roadway. I observed the vehicle pull out into the roadway from 119 Laney Walker Blvd Ext and almost cause a traffic accident. I conducted a traffic stop on the vehicle and the driver (later identified as Tyrie Blue) pulled over. Prior to conducting a traffic stop on the vehicle I observed the listed vehicle in the parking lot of 119 Laney Walker Blvd Ext drive towards the roadway and for no apparent reason back up at a high rate of speed.

I approached the vehicle and could smell the odor of marijuana coming from the vehicle. Deputy Birch S8 and I removed Mr. Blue from the vehicle. Mr. Blue was wearing a black in color shoulder bag. Deputy Birch removed the shoulder bag from Mr. Blue and I placed him into the back seat of my patrol vehicle.

Deputy Birch located a small glass container which had a gray powder substance. Deputy Birch also located two gray plastic grocery bags which contained loose marijuana.

Mr. Blue said that he snorted an unknown amount of heroin prior to being stopped. Mr. Blue said that he was not feeling well and First Responders were notified. Engine Company 1 arrived and said that Mr. Blue's pupils were pin pointed and he needed to be checked at the hospital. I transported Mr. Blue to AU and the vehicle he was operating was towed by the listed wrecker Chavous. The window tint on all of the windows was extremely dark and I was not able to see into the vehicle. I did not test the window tint due to trying to get Mr. Blue to the hospital.

I arrived at the hospital and Mr. Blue was medically cleared a short time later. Mr. Blue was charged with possession of marijuana with intent, possession of cocaine and possession of Fentanyl. Mr. Blue was also issued a citation for failure to yield while entering the roadway. The incident was captured on BWC warrants will be signed on the accused. The narcotics were filed under property receipt #514901.
