Initial Narrative By Hope Moore

On August 19th, 2023 at approximately 4:12pm, I was dispatched to a keep the peace call for service located at [REDACTED] Black Falls Rd. Dahlonega, Ga 30533.

I first met with the complainant at the Chevron gas station on Hwy 19 Business. The complainant was living at the above address; however, her and her boyfriend were splitting up and she wanted to collect her belongings.

Once arriving to the address, the complainant began to collect her belongings with the help of a few friends/family members while the ex-boyfriend was present.

Soon after, the ex-boyfriend became aggressive with me and the other party and attempted to lock everyone out of the house. The ex-boyfriend was clearly advised against this. The complainant had establish residency and her and her guests had every right to be there.

The complainant's mother was attempting to leave the residence when the complaint told her to hold the door, because they were being locked out. The mother then stopped where she stood in the middle of the doorway and the ex-boyfriend proceeded to forcibly shut the door on the mother and attempt to push her out of the residence.

I then ran over to stop the altercation and was met by passive resistance from the ex-boyfriend. He used his foot as a door stop and would not move. I was able to separate the parties, putting myself in between them, and open the door the the ex-boyfriend was trying to shut on the mother.

There was no bruising or red marks that could be seen at the time; however, the mother complained of pain on her chest area from where she was struck by the door/door frame.

The mother wanted charges pursued and the ex-boyfriend was arrested and charged with Simple Battery.
