## CONDITIONS OF PROBATION

The Defendant having been granted the privilege of serving all or part of the above stated sentence on probation, is hereby sentenced to the following conditions;

1. Pay a monthly probation supervision fee of \$30.00 per month a one-time file setup fee of \$10.00 and a \$9.00 cvf fee. 1st month
2. Pay all fines within 4 months; at a rate of \$ 213 (fines) + \$ 49 (#1/fees) = \$ 262 per month;
3. Do not violate the laws of any governmental unit. 252 EACH MONTH
4. Report to your probation supervisor as directed and permit such supervisor to visit him/her at home or elsewhere. AFTER
5. Work faithfully at suitable employment insofar as may be possible.
6. Do not change present address, move outside the jurisdiction of the Court, or leave the State without permission of the probation supervisor. 1st Report and Payment is DUE
7. Support your legal dependants to the best of your ability. on 9/23/21
8. Avoid injurious and vicious habits.


