NARRATIVE

22-229600

On 09/22/2022 at 2150 hours I, Deputy Gaiter, observed a group of males standing behind the hedges at 3026 Washington Road. The subjects were making hand to hand transactions and I saw Andre Patterson walk towards the back of 3026 Washington Road. Corporal Mealing and Deputy Morton attempted to stop Mr. Patterson. Mr. Patterson swallowed an unknown substance and had to be treated by EMS.

I stopped another male that was in the group and Corporal Phillips and Deputy Leathers asked Terrance Landers to stop. Mr. Landers ran on foot towards the back of 3020 Washington Road. I released the subject that I was dealing with to assist deputies with the subject that was fleeing. Mr. Landers ignored my commands telling him to stop. Mr. Landers reached into the black backpack he was carrying and I could not see his right hand. Mr. Landers was running away as he was reaching into the small bag. Mr. Landers stopped and turned towards Deputy Leathers and I. Mr. Landers took off the backpack and threw it over a fence. Deputy Leathers and I gave Mr. Landers multiple commands to put his hands behind his back. Mr. Landers had his right arm under his body and he was refusing to put his hands behind his back. I felt Mr. Landers tensing up his right arm. Deputy Leathers gained control of Mr. Landers right arm and I was able to place him in handcuffs.

I located a pink plastic bag underneath Mr. Landers. The pink plastic bag contained one small plastic bag of marijuana. There were multiple small plastic bags which contained a tan substance and another small bag which contained white rectangular pills. Corporal Mealing and I field tested the tan colored substance and they both tested positive for fentanyl. Deputy Leathers recovered the small black backpack and it contained a red digital scale with a white powder all over the surface. The black backpack contained the listed firearm (Taurus G3 black in color serial number #ACG064904).

The firearm was filed under property receipt #509892 and the narcotics were filed under property receipt #509893. The digital scale was filed under property receipt #509894. Warrants will be signed on the accused the incident was captured on BWC. The misdemeanor marijuana will be handled pending review. I weighed the marijuana and it weighed approximately 2 grams. The white pills weighed approximately 1.6 grams and the tan substance weighed approximately 1.7 grams.
