**On Thursday, February 13, 2025, at approximately 0120 hours, I initiated a traffic stop at 2401 S Kanner Hwy on a black Cadillac sedan with Florida license plate 07EIPL for modified exhaust and illegal window tint. I made contact with the driver, Aiden Singleton, and the passenger, later identified as Giselle Flores. During the interaction, I observed that the passenger was not wearing her seatbelt. When I requested her driver's license, she stated that she was not required to provide one.**

**The passenger was requested to exit the vehicle, which she did without incident. Once outside the vehicle, I again requested her identification, but she refused to provide it. I explained her options regarding the failure to provide identification, but she continued to refuse, stating that she did not believe she was obligated to give any information.**

**The passenger was subsequently secured in hand restraints, which were double-locked and checked for proper fit. She was then transported to the Martin County Jail. Upon arrival, she provided her identification to the**
