### NARRATIVE

**22-223749**

On 09/15/2022 at 1410 hours I, Deputy Gaiter, was checking 2027 Lumpkin Road. After receiving complaints about drug activity at the listed location. I exited my vehicle and could smell the odor of burnt marijuana where a group of subjects were standing. Micky Seward saw me and began walking at a fast pace out of the park. Mr. Seward was standing with the other subjects prior to me exiting my vehicle. I also observed children playing at the park less than 200 feet from where the subjects were standing.

Corporal Mealing and Deputy Garner stopped Mr. Seward. After speaking with him briefly Corporal Mealing patted down Mr. Seward and located a Meth pipe in the front right pocket of his pants. Corporal Mealing located .01 grams of Meth that was not packaged in the front hand pouch of Mr. Seward's hoodie. Corporal Mealing field tested the substance and it tested positive for Methamphetamine. Mr. Seward was placed under arrest. The Meth was filed under property receipt #512292 and dropped into the drug locker. The incident was captured on BWC.
