### NARRATIVE

**22-223811**

On 09/15/2022 at 1510 hours I, Deputy Gaiter, arrived at 1941 Phinizy Road with two prisoners. Mr. Young was yelling and being belligerent while in route to the jail. We arrived and the jail and I heard Mr. Young moving around. Mr. Young began whispering to Mr. Seward. I heard something fall onto the floor of my vehicle. I looked in my rear view mirror and observed Mr. Young put something into his mouth. I exited my patrol vehicle and removed him from the backseat and he began tensing up his arms. I looked in the backseat of my vehicle and he said that he was eating a piece of candy. Mr. Seward said that Mr. Young ate a piece of candy.

When I brought Mr. Young into the jail he was trying to spin towards my direction and I put him against the wall and had to hold him there until a jailer took over. Mr. Young was trying to push his body off of the wall but I would not allow him to do so until jail staff took over. The incident was not captured on BWC because I was already on scene at the jail.
