### NARRATIVE

**22-228572**

On 09/21/2022 at 2010 hours, I Deputy Gaiter, conducted a traffic stop on the listed vehicle (2014 Honda Civic black in color GA Tag#PJZ9139) for failure to dim headlights. The vehicle was traveling south on E. Boundary Street at Greene Street and the driver failed to dim their headlights for a vehicle that was passing in the opposite direction.

I conducted a traffic stop and made contact with the driver of the vehicle Teresa Butler. I advised Ms. Butler that I stopped her because she failed to dim her high beams and also she had a burnt out brake light. While speaking to Ms. Butler I could smell the odor of raw marijuana coming from the vehicle. I asked Ms. Butler was there any marijuana in the vehicle and she reached towards the gear shift. I asked her to tell me where it was and not to reach around in the vehicle for anything. Ms. Butler exited the vehicle and she said, " I smoked earlier". Deputy Evan Carter #1313 searched the vehicle and he located a black plastic grocery bag in the glove box.

I searched the black plastic bag that Deputy Carter located. The bag had 3 individual bags of marijuana. Each of the bags were wrapped in plastic and weighed approximately 29 grams each. I field tested the marijuana and Ms. Butler was placed under arrest and charged with failure to dim headlights and possession of marijuana with intent to distribute. Ms. Butler was also issued a citation for failure to dim headlights. The marijuana was filed under property receipt #512293 and warrants were signed on the accused. The traffic stop was captured on BWC .
